

PREFACE

In order to satisfy the interest of a wide circle of statistical data users, the Republic Statistical Office of Serbia publishes this complex Communication which includes basic data on socio-economic trends in Republic in the previous year, as well as data concerning the most up-to-date phenomenon which statistical recording is related to some of the previous years.

Presented data refer to numerous fields of statistical surveys: macro-economic balances, industrial and agricultural production, construction and dwelling activities, transport, trade, hotel and restaurant management and tourism, employment and salaries, pensions, prices, costs of living, education, culture, children care, etc. Among presented data there are also final results about national, age/sex composition of the population, educational attainment, literacy and activities from the Census 2002, as well as data about president elections in Serbia, held on November 16, 2003 and results of elections for national representatives to the National Assembly of Republic of Serbia held on December 28, year 2003. We also expect that data about the structure of holders of economic activities and process of restructuring and property transformation of enterprises, shops and other economical entities in the current economic environment will be in focus of the expert public.

In lack of final results about some phenomenon for the year 2003, estimated data for last month, three-month period and year are given in some chart surveys and later on the Republic Statistical Office of Serbia will also issue final results in its other editions.

Besides tabular data surveys, the Communication is also supplied with a certain number of graphs which, in best way, illustrate present socio – economic trends in the Republic of Serbia.

ANALYSIS OF BASIC INDICATORS OF SOCIO - ECONOMIC TRENDS IN THE REPUBLIC OF SERBIA FOR YEAR 2003

Basic characteristics for year 2003 are still slow down of prices growth, slight growth of total economic activities and gross domestic product at constant prices and realistic increase of salaries (wages). Total number of employees in year 2003 continued with tendency of further decrease.

Estimated growth of social product at constant prices has increased for 1,5% in comparison to the year 2002, what shows smaller growth in comparison to the previous two years. Decrease of activities for 6% or 3% is realized in the sectors of agriculture and industry, while all other sectors realized growth. The biggest growth of 11% is realized by the sectors of trade and transport and communications, as in the year 2002.

Industrial production in the year 2003 has decreased for 3% compared to the previous year. The sector of mining and quarrying realized growth of 0,8%. The sector of electricity, gas and water supply realized growth of 2,3% and manufacturing realized decrease of 4,6%.

There is a downward trend of industrial production that is registered in 23 industrial fields, what makes 62% of total industrial production. The biggest decrease is realized in the following fields: Manufacture of wearing apparel and fur (46,1%), Products of wood and cork, except furniture (28,8%), Mining of metal ores (28,8%). The biggest influence on decrease of industrial production in the year 2003 was exerted by following fields: Manufacture of textile yarns and textiles, Manufacture of wearing apparel and fur, Products of non-metal minerals, Manufacture of food products and beverages.

Growth of industrial production is realized in 4 industrial fields that in the structure of industrial production participate with 38% of production. The most significant growth is realized in the following fields: Manufacture of chemicals and chemical products (13,8%), Mining and briquetting of coal (8,3%), Electricity, gas and water supply (2,3%). Taking into account the territory, Central Serbia realized more significant decrease of industrial production (3,5 %), in comparison to Vojvodina (2,1%).

It is estimated that agricultural production realized decrease of 5,7% in the year 2003 due to unfavorable weather conditions. Crop and truck farming realized decrease of 25,9 % that was a reason of vegetable production's decrease for 15,6 %. Production of wheat and maize was outstandingly small that realized fall of 39,1%, or 31,7%, compared to the previous year. From the other side, production of sunflower, plums and raspberries ranged above ten year's average, so fruit growing realized growth of 122,6% and viticulture of 14,1%, compared to the previous year. It is estimated that livestock production decreased for 0,9%, cattle breeding for 3% and hog raising increased for 1%. It is because breeding stock has increased for 1%.

In the sector of transport, total transport services have increased for 0,4% in comparison to the previous year. Travelers' transport registers decrease of 2,3% in contrast to goods transport that is bigger for 14,3% due to the growth of transport's scope in all kinds of international transport.

In the sector of communications, in relation to the previous year, there is a high rate of growth for 24,8%. Post activities, after growth in last few years, show decrease of 7,6%. Index of the physical scope of services in telecommunications registers growth of 26,7%, above all due to services growth in the mobile telephony.

In internal trade, growth of goods turnover in retail trade is realized for 12,0% (at constant prices) compared to the previous year, what is continuation of the trend from the previous period.

External trade's goods exchange has increased for 27,5% in comparison to the year 2002. Export has increased for 19,4% and import for 30,5%. Shortage of external trade's turnover exceeds almost twice value of realized export. Import value is covered with only 33,8% of the value of export.

Comment: In indicators for 2001, 2002 and 2003 data for Kosovo and Metohia are not included.

Average annual retail prices' growth is 11,7% what is the smallest growth during the last seventeen years, while growth for twelve months (from December 2002 until December 2003) is 7,8%. Prices of goods increased for 7,5%, while services realized bigger growth in the year 2003 (25%). Retail prices of industrial and food products realized decrease of 0,1%. Average annual growth of living expenses' index amounted to 9,9%, while growth in December amounted only to 0,9%. The largest influence on that growth was exerted by prices of dwelling. Average annual growth of catering services' prices amounted to 10,5%, and that was due to growth of prices of nights for 29,1%. Average annual growth of prices of industrial products' producers is 4,6%, while producers' prices of agricultural products and fishing realized decrease of 1%.

Total number of employees in the year 2003 decreased for 1,9% in comparison to the previous year. Number of employees in economic activities decreased for 9,9%, and number of self-employed persons and their employees increased for 10,3%.

Average salary (wage) in the Republic of Serbia for the year 2003, without taxes and contributions, amounted to 11500 dinars, nominally was bigger for 24,9% and realistically for 13,6%. Average salary (wage) in economic activities amounted to 10648 dinars, nominally was bigger for 22,2% and realistically for 11,2%. Average salary (wage) in non-economic activities amounted to 13749 dinars, nominally was bigger for 28,4 % and realistically for 16,8%. The largest average salary (wage) in the Republic of Serbia in the year 2003 (24157 dinars) was realized by employees in the sector of financial intermediation, and lowest salary - wage (7999 dinars) was realized by employees in the sector of hotels and restaurants.

In the year 2003, number of units in the register increased for 2,9% compared to the year 2002. According to the type of ownership, number of units in social ownership decreased for 14,5%, but number of units in private ownership increased for 2,5%, so for December 31, 2003 there were 76,8 units in the private ownership, without taking into account mixed ownership.

In the school year 2003/2004, 200249 students enrolled in the faculties and high schools and in comparison to the previous year, it is growth of 1,5%. In the year 2003, one could notice continuation of upward trend in number of graduated students at faculties and high schools and in comparison to the year 2001, it has increased for 9%, that will say in the year 2003, 18548 students were rewarded diploma.

In table reviews of Statistics of Population, there are data for Central Serbia and Vojvodina available. We don't dispose of data on vital statistics for the territory of Kosovo and Metohia from the year 1998, while Census 2002 on this territory has not been conducted.

Birth rate in the year 2002, compared to the year 2001, increased for 0,5% in Central Serbia, while it decreased for 0,4% in Vojvodina. Mortality rate increased for 1,1% in Central Serbia, and in Vojvodina for 0,1%.

Population growth rate decreased for 0,6% in Central Serbia, and in Vojvodina for 0,5%.

As in the year 2001, main causes of death were diseases of circulatory system (55,2%), neoplasm (18,3%) and injuries, poisonings and effects of external causes (3,8%).

In the period between Censuses 1991 and 2002 number of illiterate persons decreased significantly. Among population aged 10 and over, according to the Census 1991, there were 9,7% illiterate persons (648814), and year 2002 only 3,4% (232925).

Educational structure of population was also improved. In the scope of population aged 15 and over, share of persons without educational attainment decreased from 9,4% in the year 1991 to 5,7% in the year 2002. There was also tendency of increase of persons with secondary education (from 24,4% in the year 1991 to 41,1% in the year 2002), as well as with high and higher education (from 8,7% in the year 1991 to 11,0% in the year 2002).

When using census results one should take care that there is no complete comparability of definitions of permanent or total population in Censuses 1991 and 2002.

According to the definition from the Census 1991 permanent population includes Yugoslav citizens temporarily living or working abroad shorter than one year, as well as foreign citizens who have worked or resided in our country as family members for more than a year.

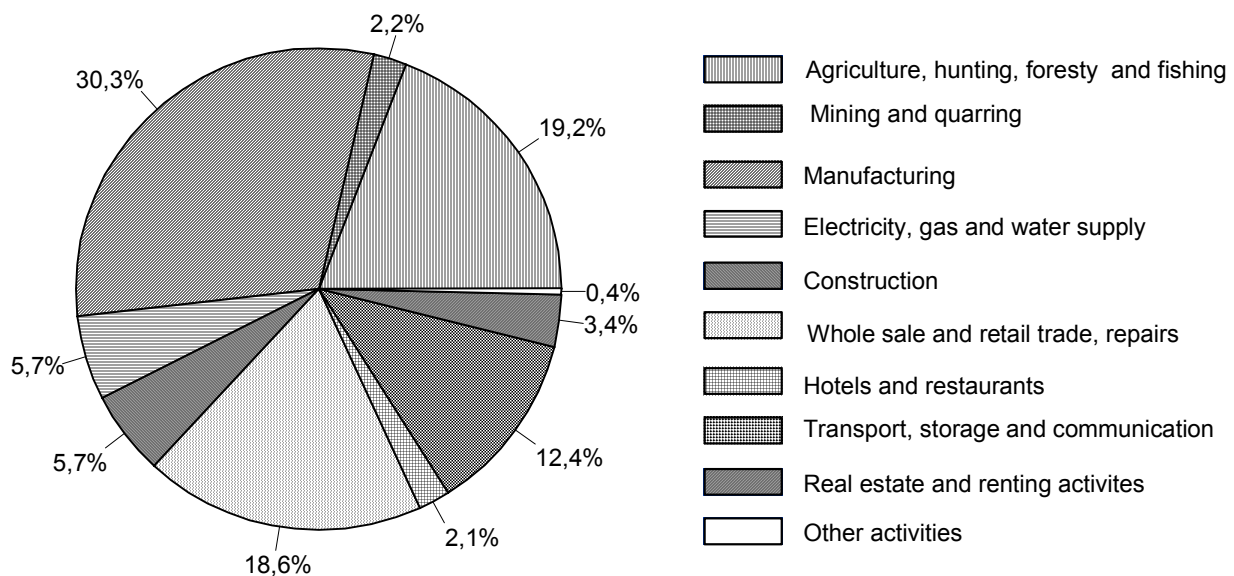

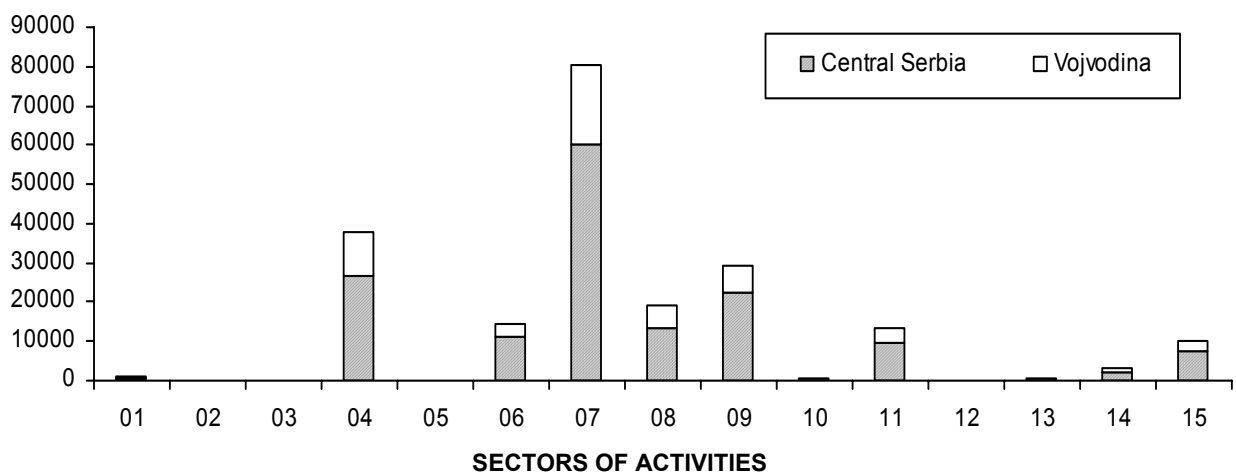

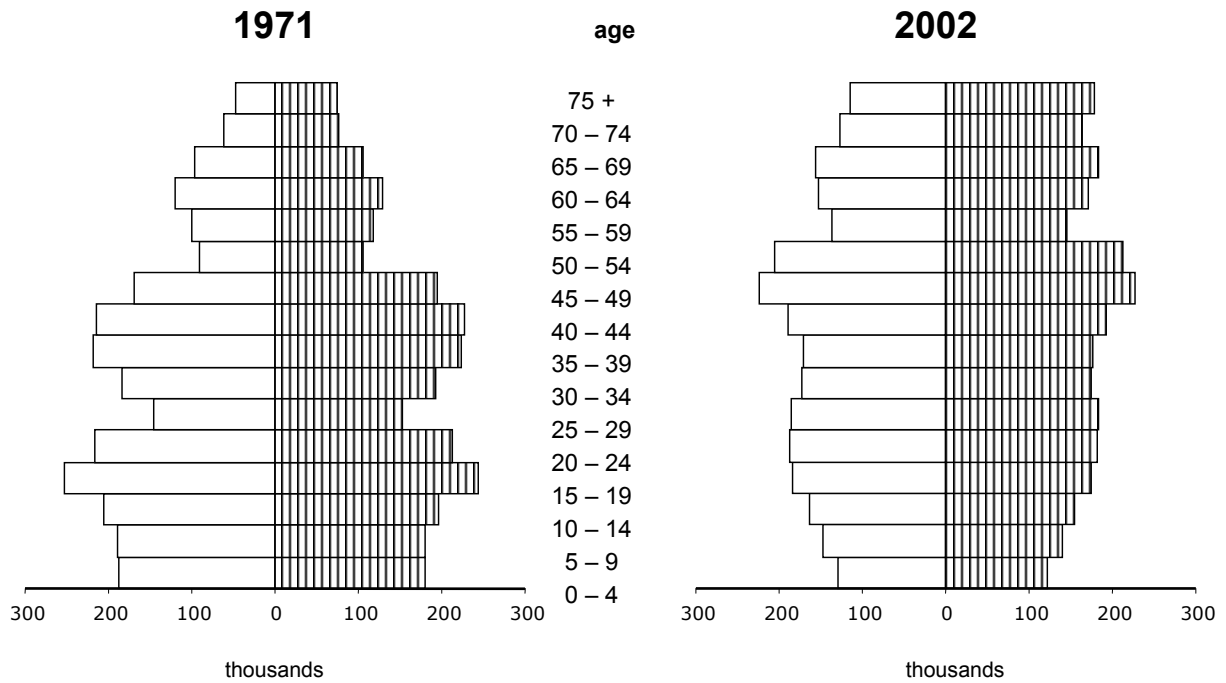

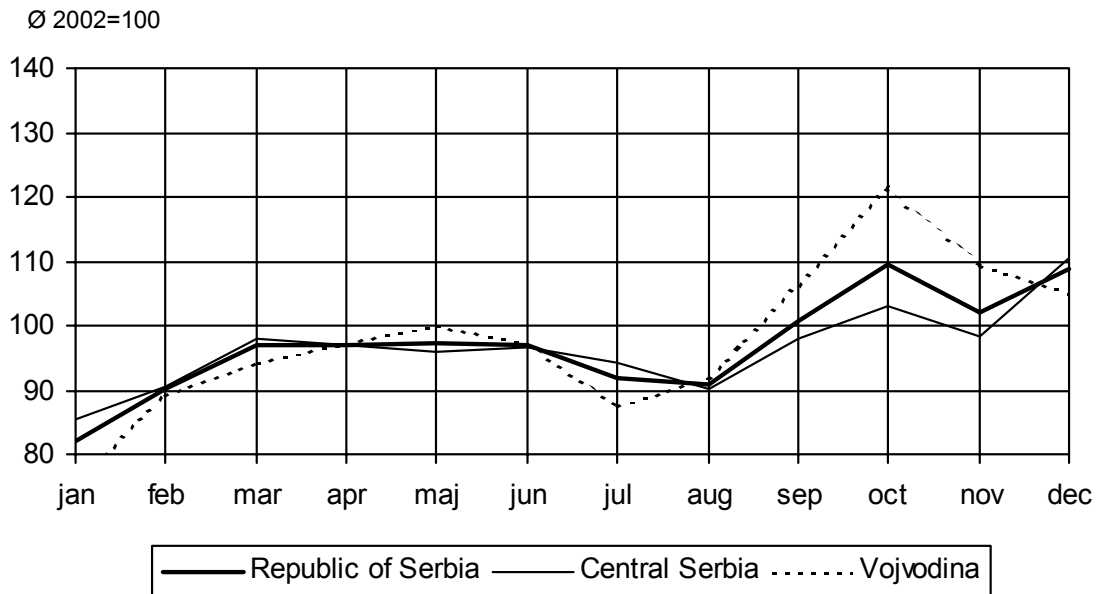

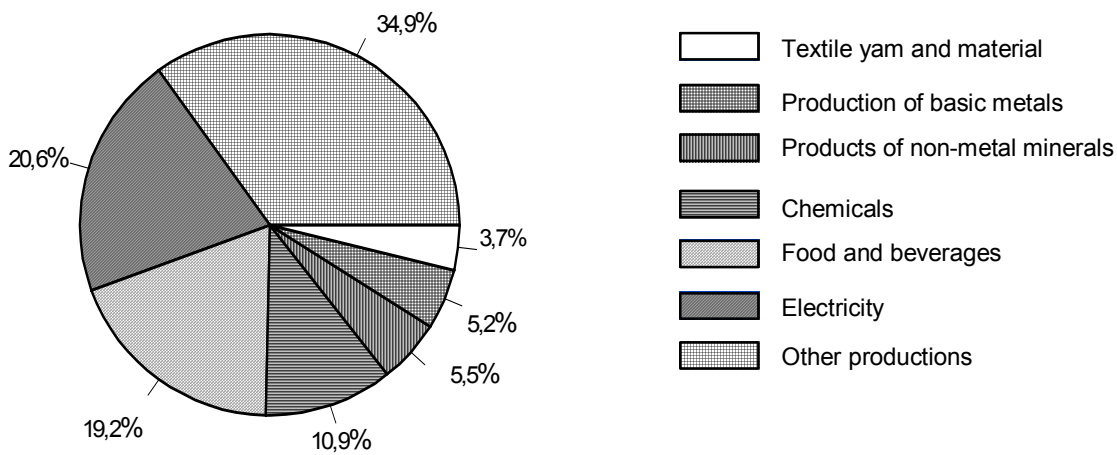

INDUSTRIAL PRODUCTION IN THE REPUBLIC OF SERBIA, 2003

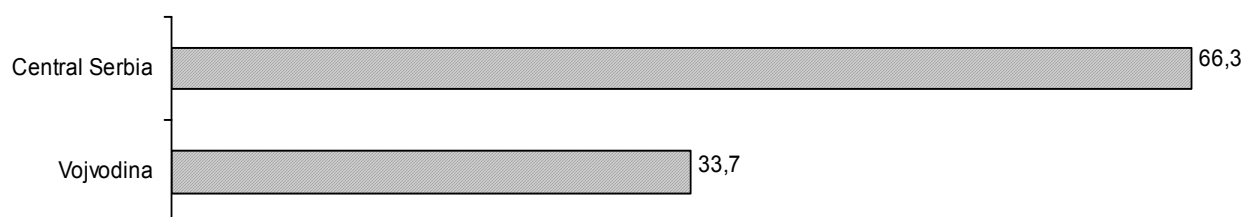
INDICES OF INDUSTRIAL PRODUCTION

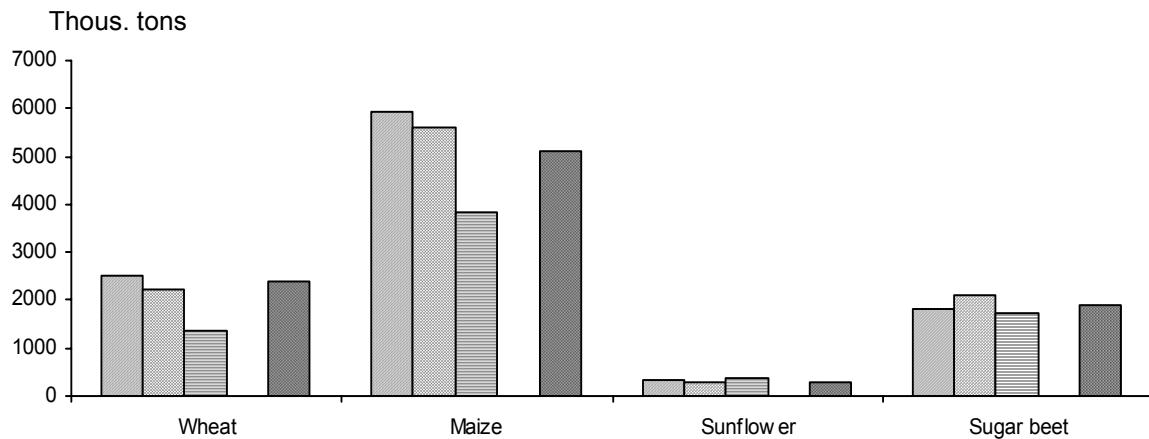

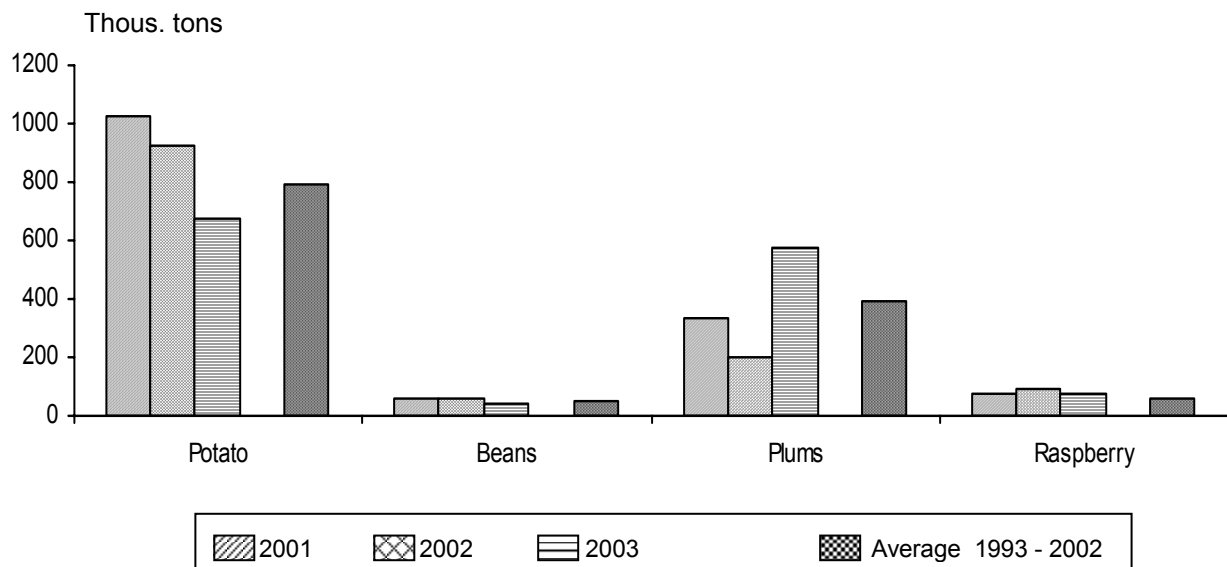

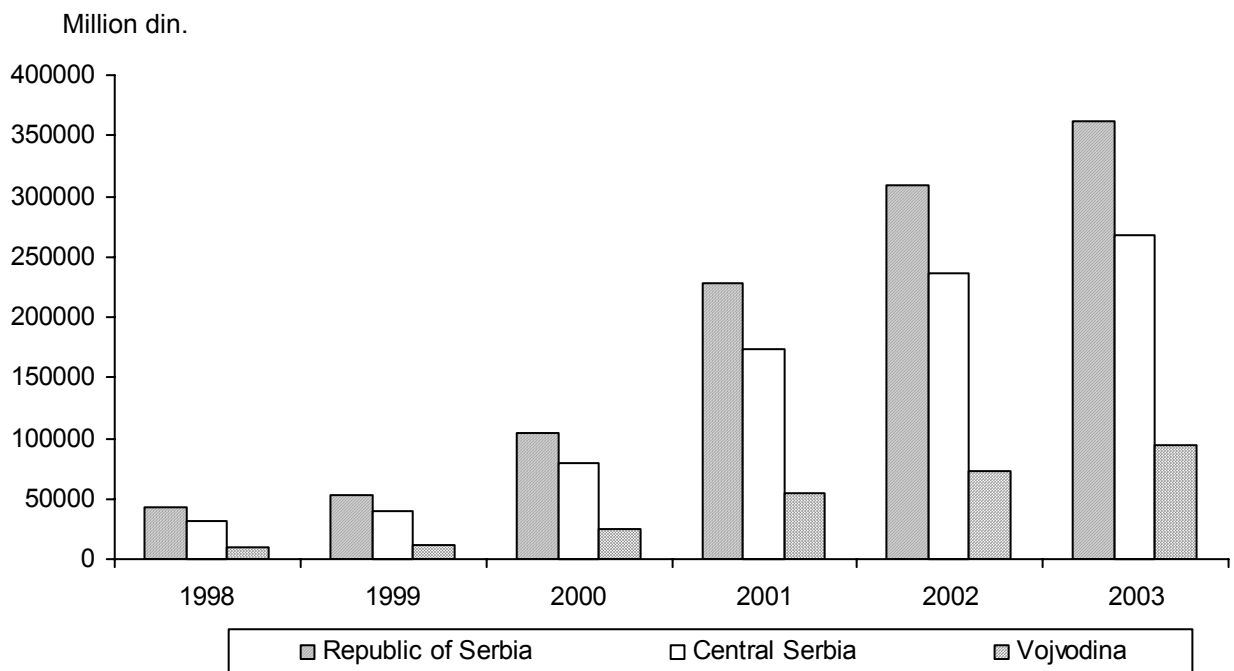
TURNOVER IN TRADE IN THE PERIOD OF 1997 – 2003

TURNOVER IN WHOLESALE

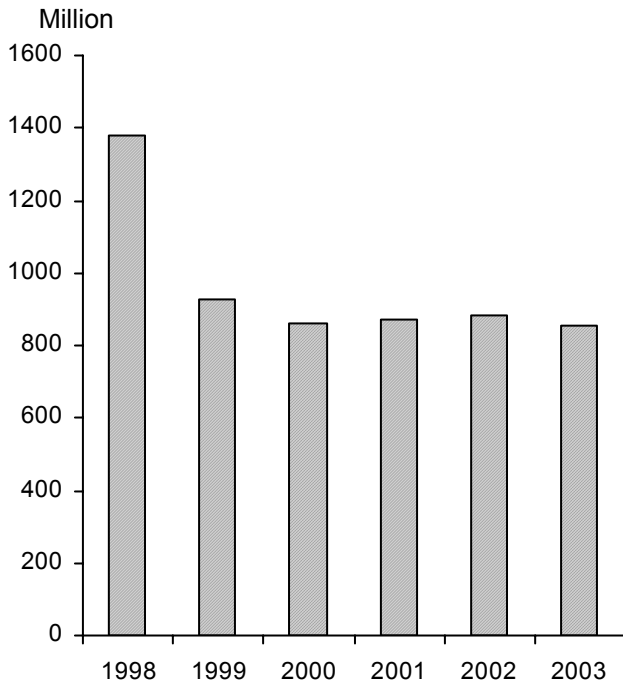


TURNOVER IN RETAIL TRADE

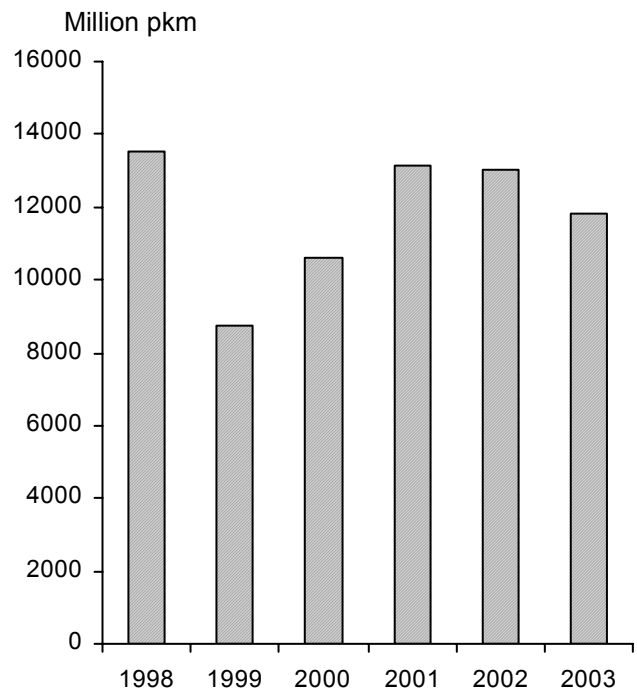

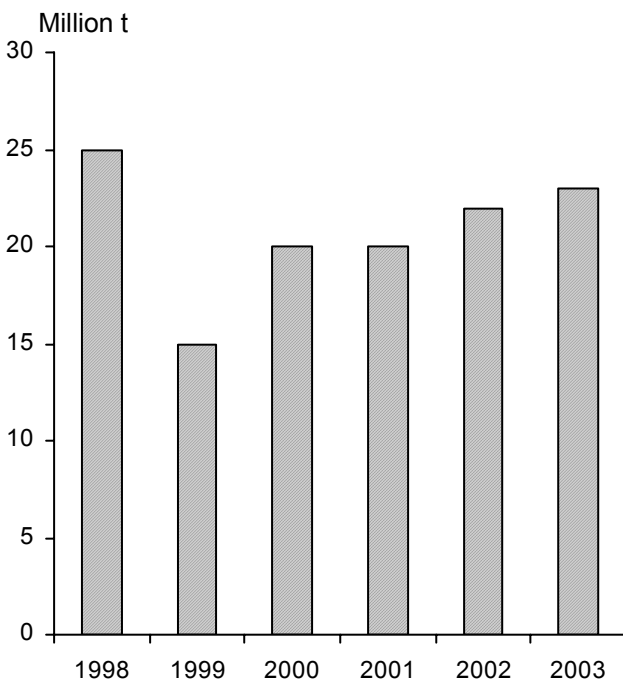
TRANSPORTED PASSENGERS



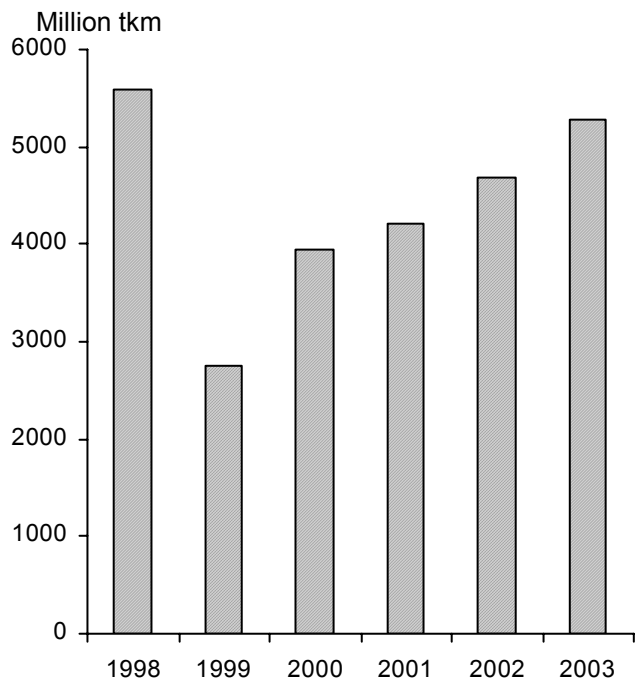
PASSENGER – KILOMETERS

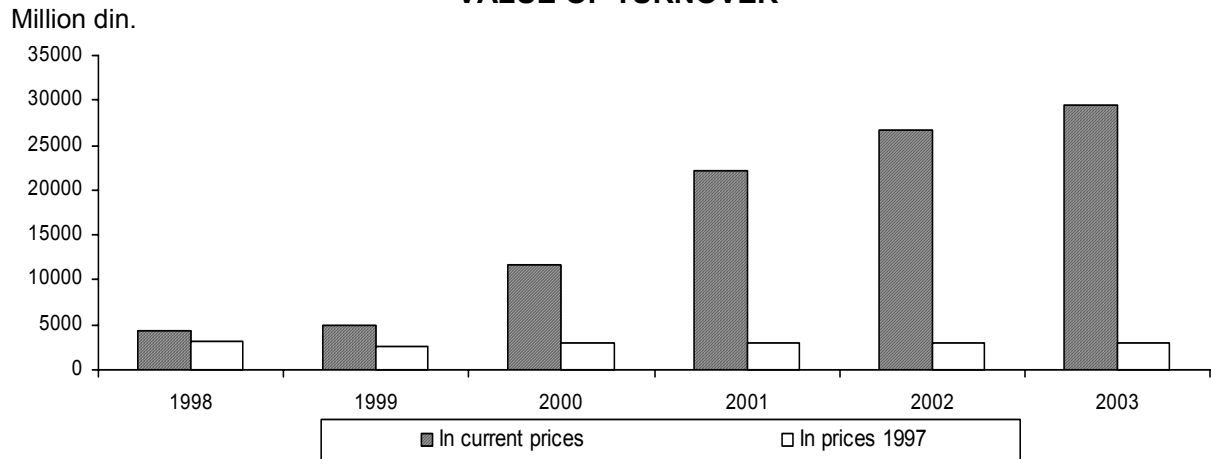

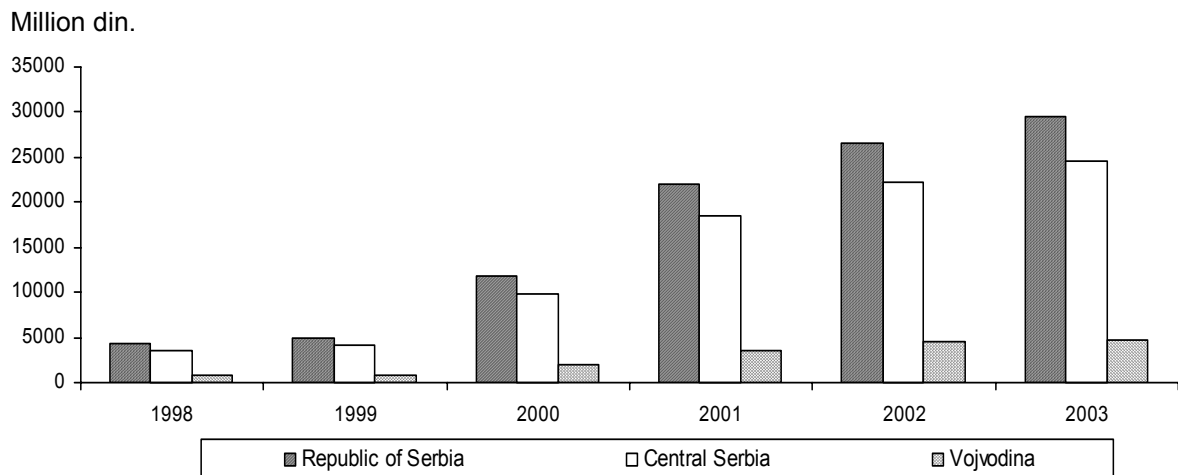


TURNOVER IN CATERING TRADE IN THE PERIOD OF 1998 – 2003 – Republic of Serbia –

VALUE OF TURNOVER

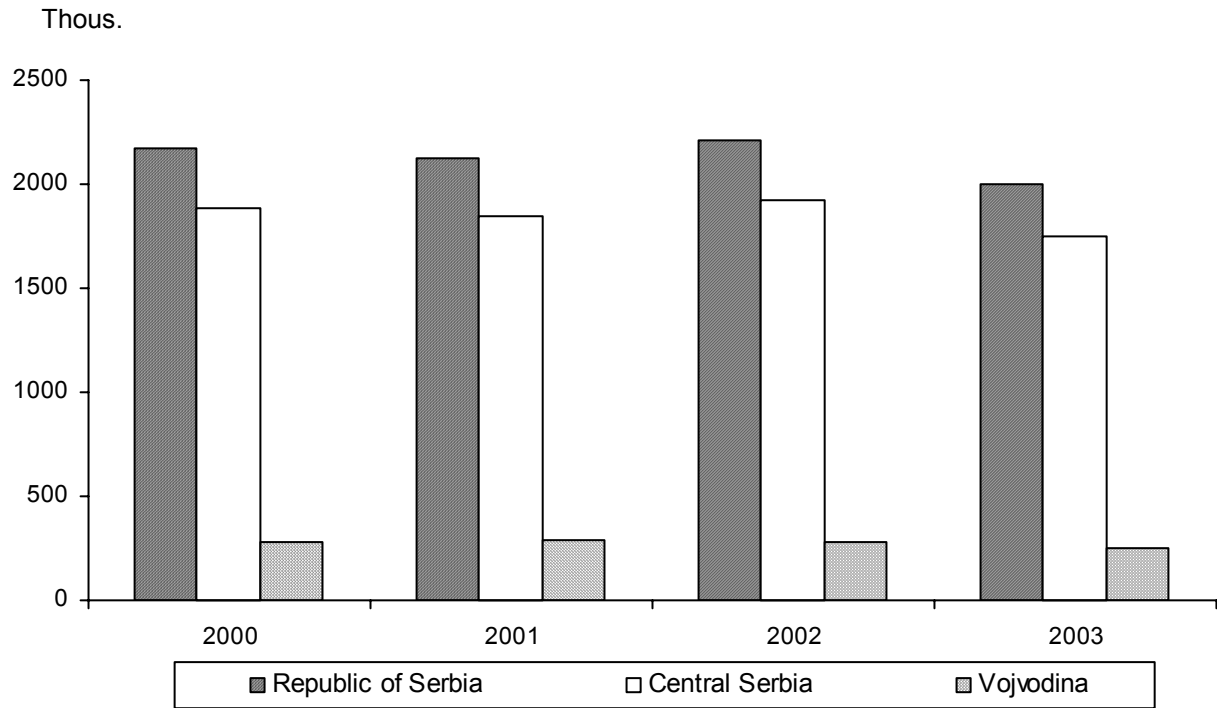


VALUE OF TURNOVER BY REGIONS

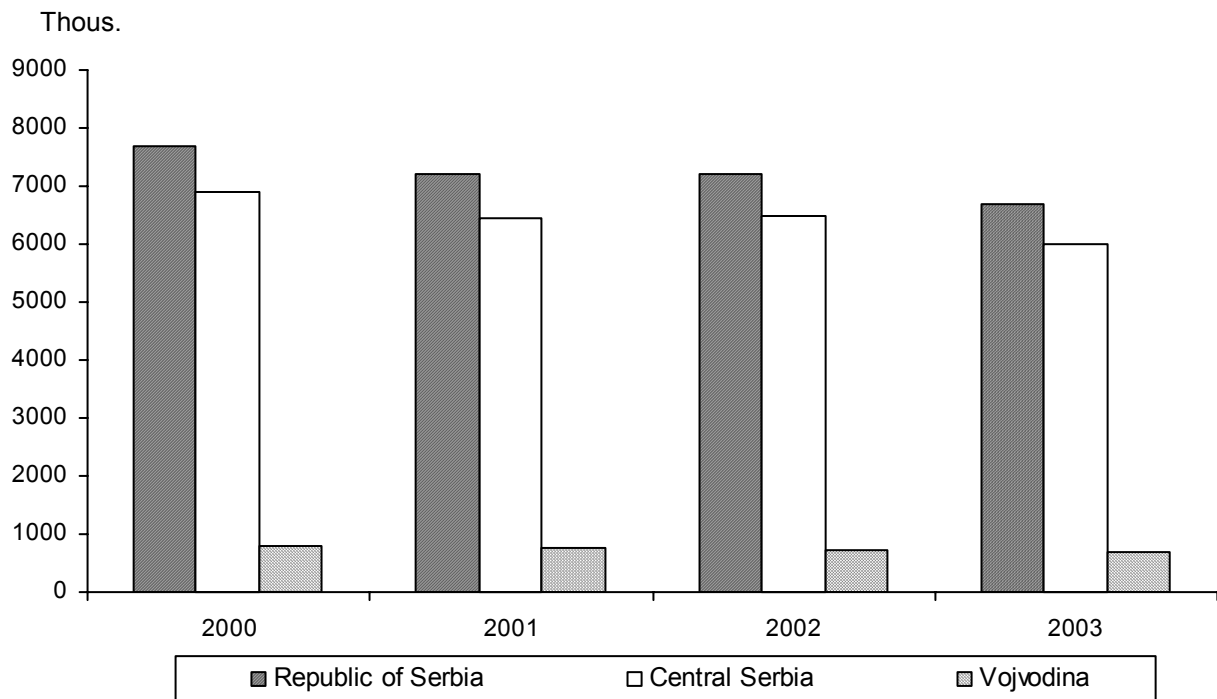

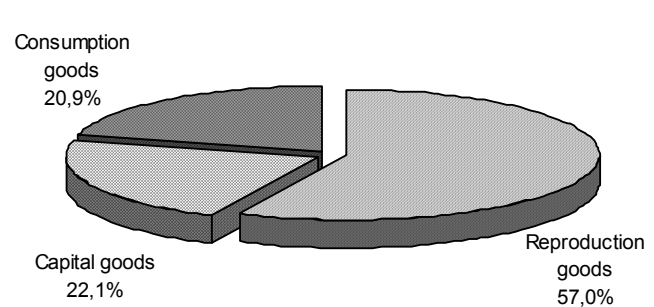

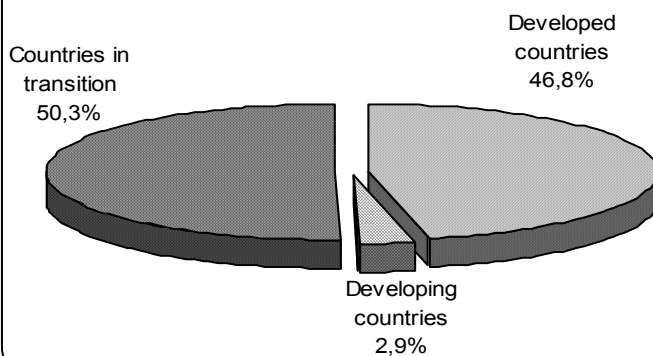

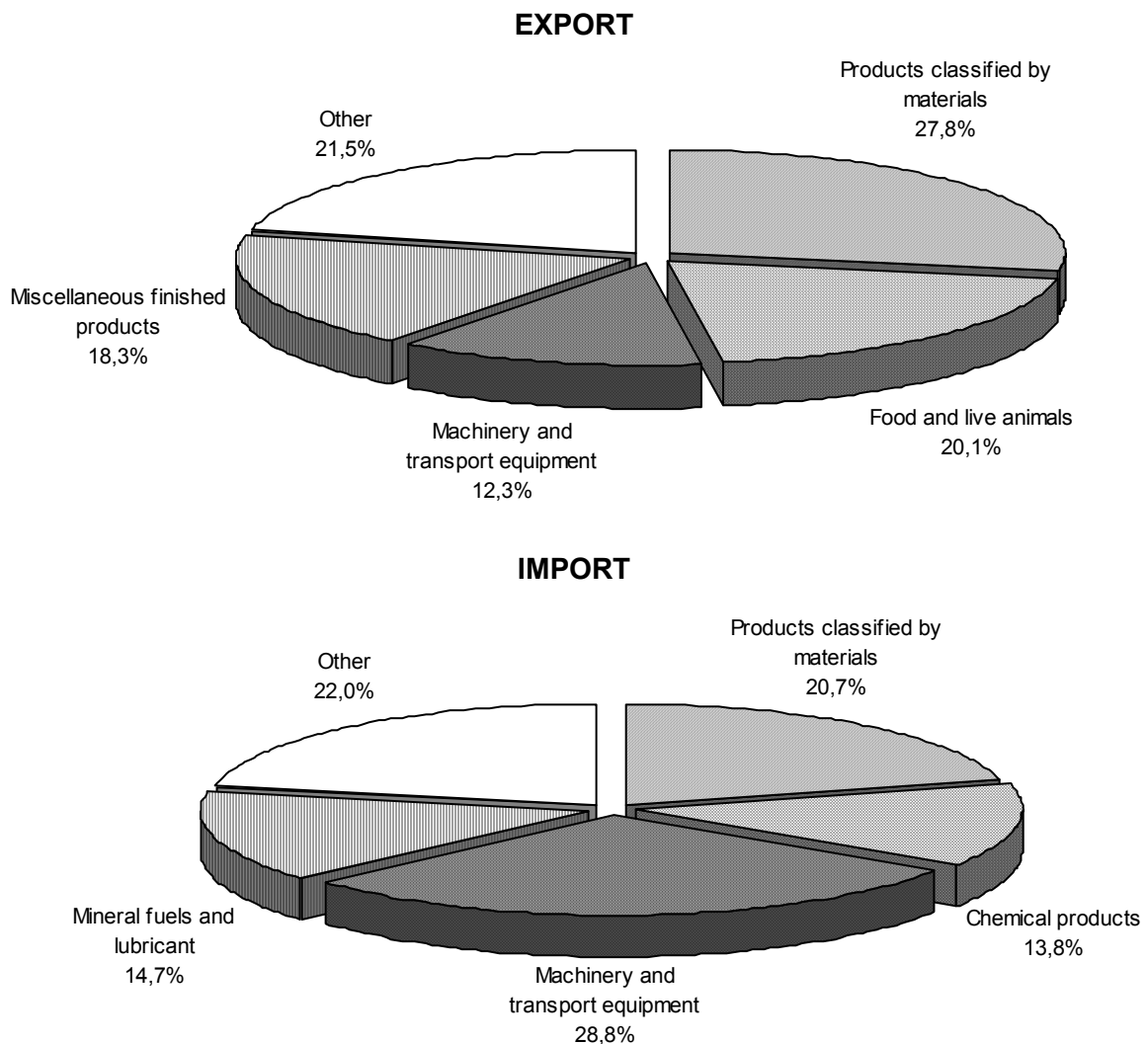

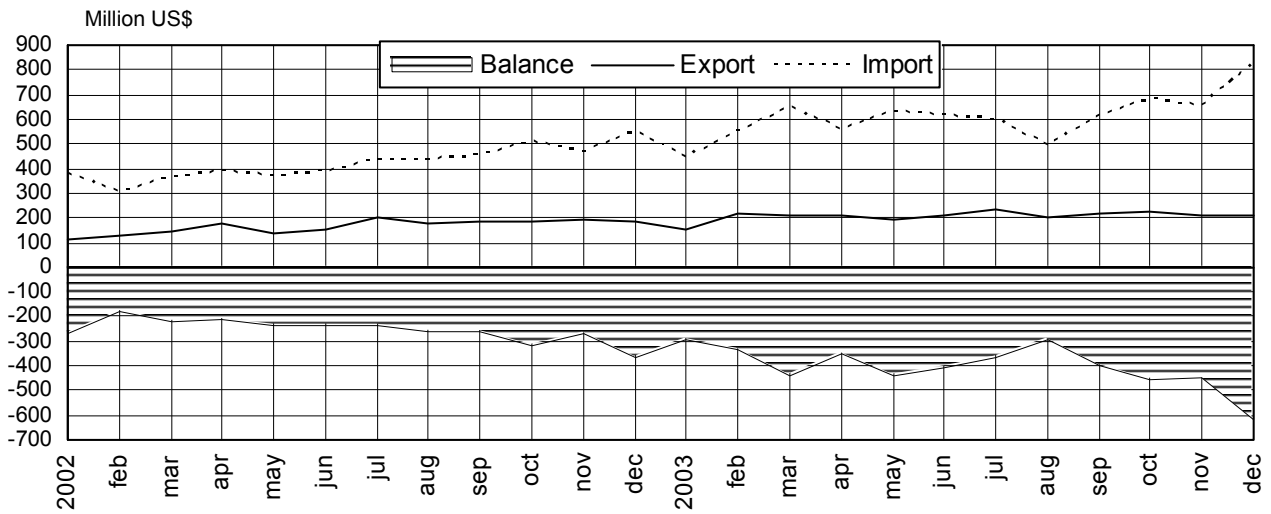

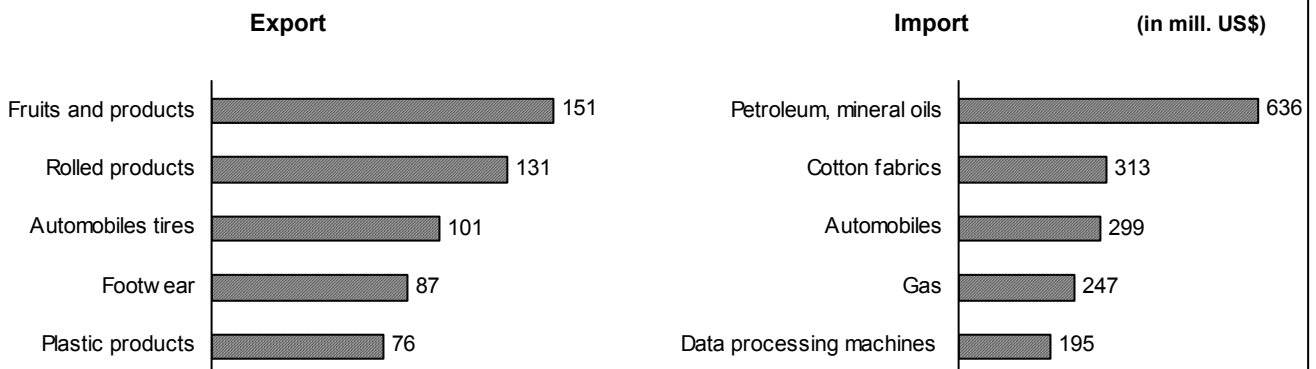
**PERCENTUAL SHARE OF COMMODITY SECTORS IN EXPORT AND IMPORT, 2003

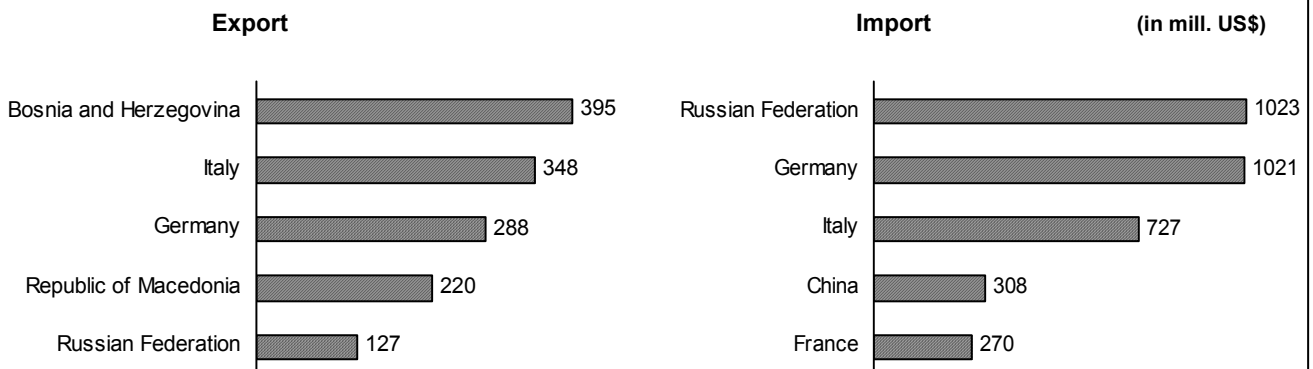
FOREIGN TRADE EXCHANGE OF THE REPUBLIC OF SERBIA
