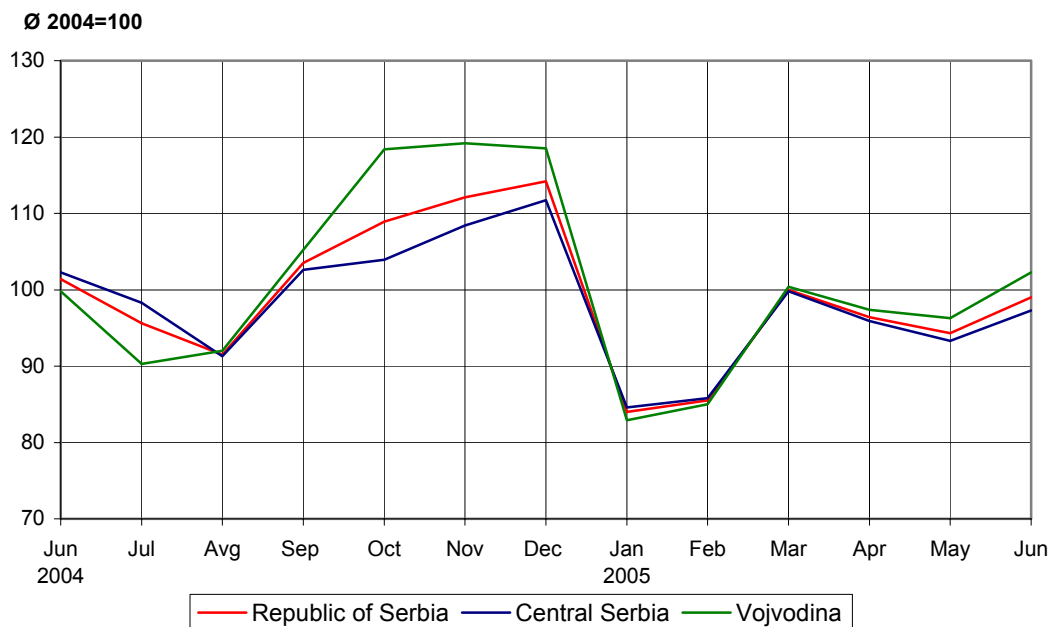

¹⁾The estimate of the industrial production of small-sized enterprises that are not covered by regular statistical surveys of industry was made for June 2005. The estimate was made on the basis of the sample. If the estimate of industrial production of small-sized enterprises is included, the industrial production index for June 2005/2004 average, for total industrial production stands at 99,1 and for manufacturing 103,7.

Industrial production in the Republic of Serbia, in June 2005 was by 1,0% lower compared to 2004 average and was by 2,3% lower compared to June 2004. Industrial production for January - June 2005, compared to the same period last year was by 2,1% lower.

Observed by sectors, June 2005, compared to 2004 average, in the mining and quarrying sector saw a 7,5% fall, while the production in the manufacturing sector increased by 3,5%, while the production in the sector for electricity, gas and water supply saw a 18,4% fall.
