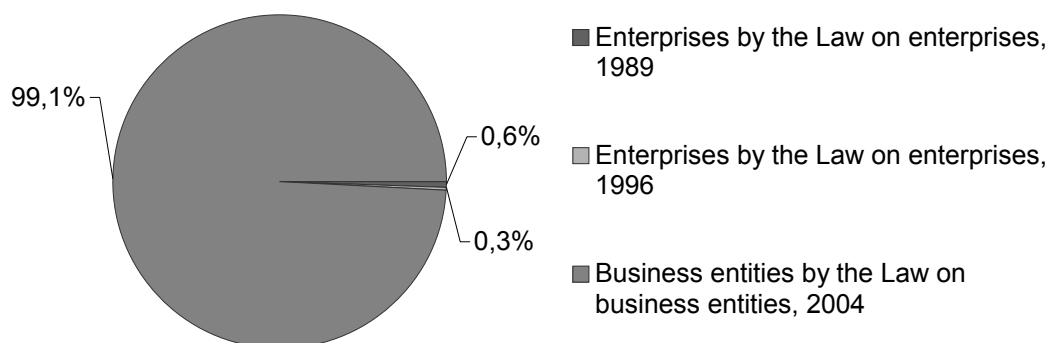

Data on the number of pre-registered and new business entities after January the 1st 2005 are resumed from Serbian Business Registers Agency (SBRA).

Total number of registration units is shown in communications SR10, SR10P and SR20.
