NOTE: The Core inflation has been calculated on the basis of changes in retail prices of goods and services which prices are being formed according to the terms of the market. It does not include prices of goods and services in some treatment of regulation (light and fuel, public utility services, PTT and other services, medicines, cigarettes, etc.) neither agricultural products which prices are directly seasonally adjusted.
