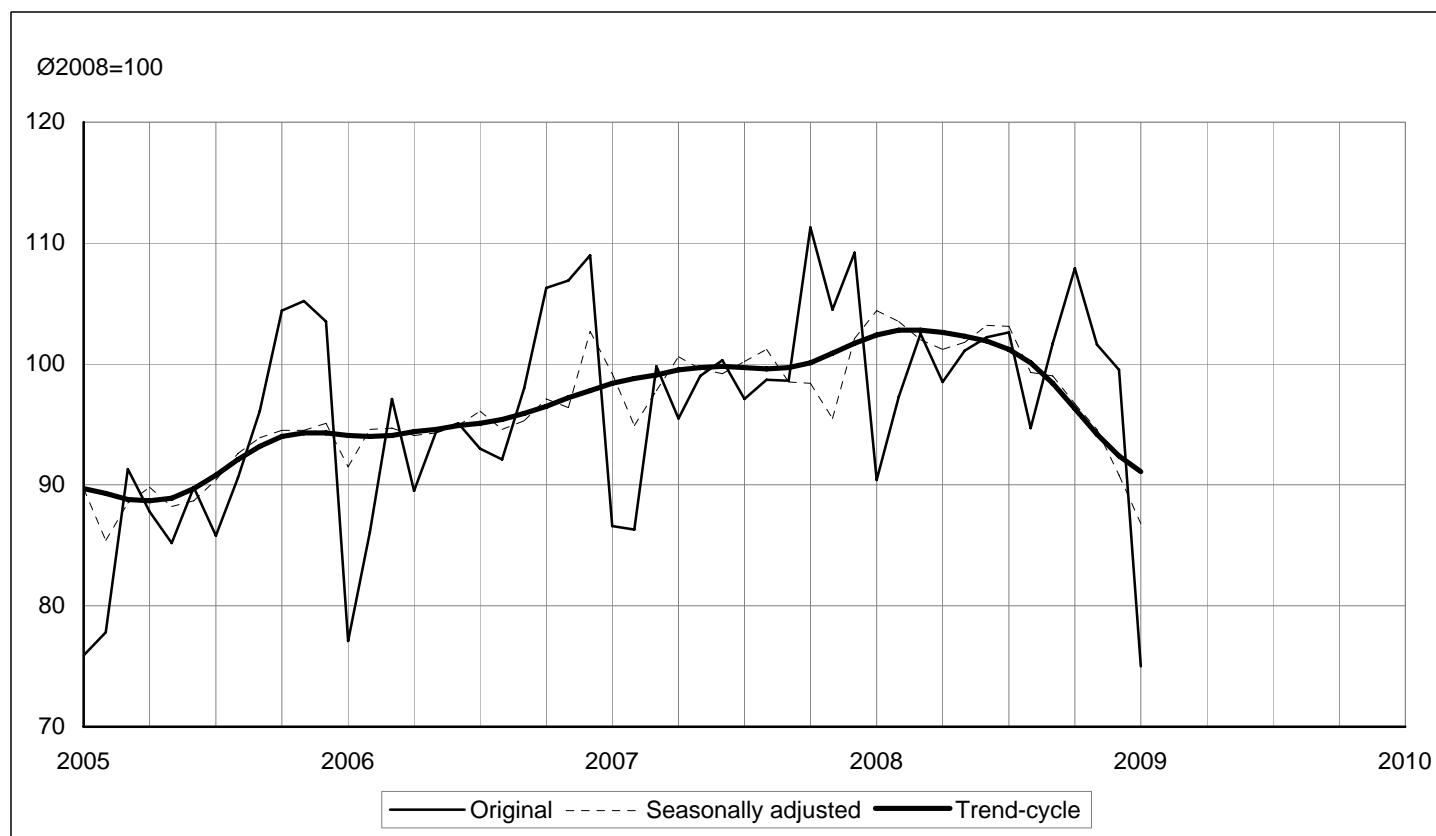


Industrial production indices, January 2009 - Previous results -

¹⁾ The estimate of the industrial production of small-sized enterprises that are not covered by regular statistical surveys of industry was made for January 2009. The estimate was made on the basis of the sample. If the estimate of industrial production of small-sized enterprises is included, the industrial production index for January 2009/2008 average, for total industrial production stands at 77,6 and for manufacturing 65,0.

Industrial production in the Republic of Serbia, in January 2009 was by 17,1% lower compared to January 2008 and was by 25,0% lower compared to 2008 average.

Observed by sectors, January 2009, compared to January 2008, in the mining and quarrying sector saw a 7,7% fall, while the production in the manufacturing sector saw a 24,5% fall, while the production in the sector for electricity, gas and water supply increased by 0,3%.
