456 028 freight road vehicles exited from the territory of the Republic of Serbia in 2008 over international road border crossings and 6336 thousand tons of goods were exported. Relative to 2007, number of freight road vehicles in exit increased by 10.1 % and quantity of exported goods increased by 11.2 %. Vehicles with registration of the Republic of Serbia, in 2008, carried somewhat less than a half of total quantity of the exported goods. Number of freight vehicles that imported goods to the territory of the Republic of Serbia in 2008 increased by 8.5 % compared to 2007. Vehicles with registration of the Republic of Serbia, in 2008, transported 58.5 % of total quantity of the imported goods. Transit of freight vehicles in the road network of Serbia in 2007 decreased by 35.3 % compared to 2006, primarily due to Romania and Bulgaria accession to the European Union. It caused change in travel itinerary that moved from our country's roads to the roads of the before mentioned countries. Although the transport path is longer, expressed in kilometers, total time of goods transport to the countries of loading or unloading is shortened because of shorter keeping of vehicles at border crossings (customs administration). In 2008, number of freight vehicles in transit over the territory of Serbia mostly stagnated, compared to 2007, but was still smaller, relative to 2006. Comparing 2008 with 2007, 6.3 % more goods were transported in transit over road network of Serbia. As it was the case in the previous years, somewhat less than 50 % of freight vehicles in transit were with registration of Turkey.
