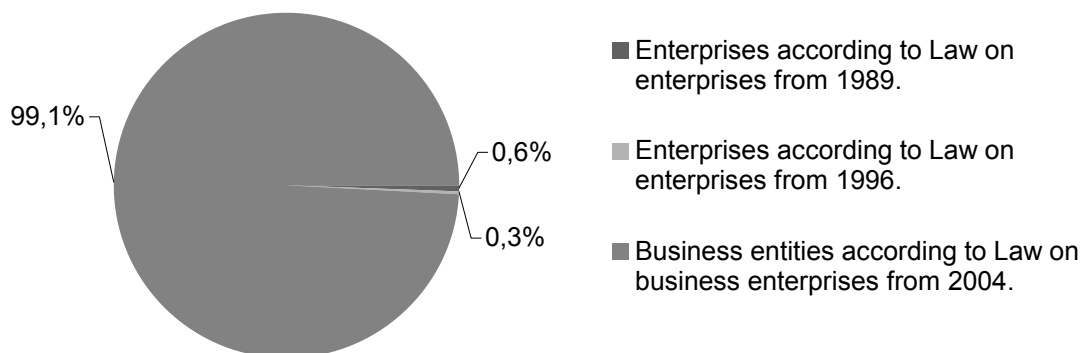

Data on the number of pre-registered and new business entities after January 1<sup>st</sup> 2005 are resumed from Serbian Business Registers Agency (SBRA).

Total number of registration units is shown in communications SR10P and SR20.
