SAŽETAK

SUMMARY

Informacije o radu drumskog teretnog voznog parka neophodne su za analizu ukupnih ekonomskih kretanja u oblasti saobraćaja, kao i analizu učestvovanja pojedinih grana saobraćaja u realizaciji ukupnih tokova prevoza tereta. Tokom 2008. godine izvršeno je probno statističko istraživanje o radu teretnih vozila registrovanih u Republici Srbiji, koja je korisna nosivost veća od 3,5 tona, sa čim se dobiju podaci o radu teretnog voznog parka registrovanog za javni drumski prevoz i prevoz za sopstvene potrebe.

Pripremljena su jedinstvena metodološka rešenja data u evropskoj Regulativi 1172/98. Time je obezbeđena uporednost dobijenih podataka sa podacima koje, za ovu pri vrednu oblast, iskazuju sve zemlje Evrope.

Međutim, rezultati dobijeni probnim istraživanjem, s obzirom na znatno manji period posmatranja od previđenog Regulativom, obezbeđuju validne podatke samo za najvišeg nivoa agregiranja.

Information on road freight transport vehicles are necessary for efficient analysis of transport economics, as well as analysis of participation of various transport modes in freight transport as a whole. During 2008, a pilot statistical survey has been conducted to collect the data on working effects of freight transport vehicles, registered in the Republic of Serbia, with load capacity of over 3.5 tones. The aim of the survey was to figure out the working structure of transport for hire or reward and transport on own account.

The methodology applied is the one recommended by the EU, Regulation No.1172/98. In this way, provided data are comparable with analogues data of other European countries.

However, data provided by pilot survey can be considered valid only on higher aggregate levels, as the observation period is much shorter than the period recommended by the EU Regulation, mentioned above.

UVOD

Drumski saobraćaj se može veoma razlikovati definisati sa stanovišta mesta gde se odvija, vrste i vlasništva nad sredstvi ma sa koji ma se prevoz obavlja. Drumski prevoz u najširem smislu obuhvata celokupan prevoz putnika i robe drumskim prevoznim sredstvi ma.

Ovaj prevoz se vrši na javnim putevi ma i na putevi ma unutar poćopri vrednih ićumski h gazdi nstava, f abrika, i td. U ućem smislu, pod

drumski m prevozom podrazumeva samo prevoz putnika i robe na javnim putevi ma, koji se vrši drumskim motornim ićpri kću-nim sredstvi ma, ićija je osnovna namena prevoz putnika i robe.

Organizacija prevoza, kao ić pristup trćićtu saobraćajnih usluga, delić ukupan drumski saobraćaj na javni drumski saobraćaj ić drumski saobraćaj za sopstvene potrebe.

Pod javnim drumskim prevozom podrazumeva se prevoz putnika i robe koji vlasnici prevoznih sredstva obave uz nadoknadu za račun trećih lica. Pod drumskim prevozom za sopstvene potrebe podrazumeva se prevoz putnika i robe na javnim putevima drumskim prevoznim sredstvom, koja su prema konstrukciji i nameni predviđena za prevoz putnika i robe, i ako se isti obavljaju za potrebe preduzeća, koja je u isto vreme pravni vlasnik vozila.

Statističko istraživanje o prevozu robe u javnom drumskom saobraćaju prati se neprekidno od 1946. godine pojedinstvenom metodologijom, koja je usklajena sa metodološkim preporukama Komiteta za unutrašnji transport Evropske ekonomske komisije. Statističko istraživanje o prevozu robe u drumskom saobraćaju za sopstvene potrebe prati se u diskontinuitetu od 1954. godine. U pojedinih periodima sprovedena istraživanja pri merenju su različita metodološka rešenja u pogledu definisanja osnovnog skupa, obuhvata jediničnog posmatranja, periodičnosti prikupljanja i objavljivanja rezultata istraživanja. Model harmonizacije serije podataka izmeđupriodakada su primenjena različita metodološka rešenja u sprovedenju istraživanja, kao i model procene obimnirada u periodikada nije sprovedeno istraživanje, dat je u ediciji Studije, analize i prikladi, br. 138 u izdavanju Saveznog zavoda za statistiku.

Istraživanje u vidu navedene nedostatke, kao i pribavljene informacije da se u celokupnom evropskom okruženju posle 2005. godine primenjuje jedinstvena metodologija za statističko praćenje drumskog saobraćaja, tokom 2008. godine, uz saradnju stručnjaka iz statistike Francuske, realizovano je probno istraživanje o radu ukupnog voznog parka u drumskom saobraćaju. Rezultati istraživanja iz 2008. godine, uz serije podataka iz istraživanja sprovedenim u periodu 1985-2000. godine, kao i procene koje su rađene za period 2000-2007. godine, dati su u datom tekstu ovog materijala.

Metodološka osnova istraživanja sprovedena u 2008. godini je Regulativa 1172/98. Ovom regulativom definisane su metodološke osnove istraživanja, odnosno definisana je lista promerivih, obuhvat, klasifikacije i ostala pravila za realizaciju ovog istraživanja. Pored ove regulative primenjene su i: Regulativa 2691/99 koja je dopuna prethodnoj regulativi u vezi kodiranih mesta utovara i istovara, Regulativa 2163/2001 koja se odnosi na serije podataka koje se šalju EUROSTAT-u, kao i Regulativa 6/2003 koja se odnosi na desimilijardne podataka.


1. UKUPAN PREVOZ ROBE U REPUBLICI SRBIJI

Ukupan prevoz robe ostvaren u svim granama saobra}aja iskazan u koli}ini prevezene robe u periodu 1991-2008. godine opadao je po prose~noj godi}voj stopi od 0,4% (Tab. 1. i Graf. 1).

Prevoz robe `elezni~kim saobra}ajem smawivao se po prose~noj godi}voj stopi od 2,7%, a saobra}aj unutra}wim plovnim putevima po stopi od 4,4%. Jedino cevovodni transport i drumski saobra}aj u istom periodu bele}i prose~an godi}wi rast po stopi od 2,3%, odnosno 0,25%.

Ukupan rad i skazan u tonskim kilometrima u istom periodu smawivao se po prose~noj godi}voj stopi od 0,3%, pri ~emu `elezni~ki saobra}aj i saobra}aj unutra}wim plovnim putevima i skazuju pad po prose~noj godi}voj stopi od 1,3%, odnosno 4,3%. U istom periodu, drumski saobra}aj bele}i rast po prose~noj godi}voj stopi od 1,0% i cevovodni transport po prose~noj godi}voj stopi od 0,4%.


Graf. 1. Ukupan prevoz robe po vidovima saobra}aja, 1991 = 100



Ukupan unutra}wi prevoz robe i skazan u koli}ini prevezene robe u periodu od 1991. do 2008. godine smawivao se po prose~noj godi}voj stopi od 0,9%, a obim rada i skazan u *tkm* smawivao se po prose~noj godi}voj stopi

od 1,9%. Za razliku od tendencija u unutra}wem prevozu robe, svi vidovi me}unarodnog drumskog saobra}aja u istom periodu i skazuju zna~ajan rast obima prevoza (vi d. Graf. 2).

Izvoz robe u posmatranom periodu realizovan domaćim prevoznim sredstvima rastao je po prosečnoj godišnjoj stopi od 2,6%, uvoz robe po stopi od 3,0% i prevozi između stranih zemalja po prosečnoj godišnjoj stopi od 9,4%.

2. UKUPAN PREVOZ ROBE U DRUMSKOM SAOBRAĆAJU

Osnovna karakteristika putne mreže u Republici Srbiji je wena relativna razvijenost u pogledu gustoće, pri čemu je neuporedivo razvijenija u severozapadnom delu zemlje u odnosu na jugoistočni deo. Vrednost prosečnog puta prevoza jedne tone robe nije velika jer su značajniji privredni subjekti koncentrisani u severnom delu zemlje, kao i na pravcu zapad-istok. Sa stanovišta razvoja međunarodnog drumskog saobraćaja, Republika Srbija se nalazi na raskršnici najkraćih tranzitnih pravaca između Zapadne Evrope i Bliskog i Srednjeg istoka, kao i između zemalja Srednje i Severne Evrope i zemalja Južne Evrope i Bliskog istoka.

U periodu 1991-2008. godine prevoz robe u Republici Srbiji rastao je po prosečnoj godišnjoj stopi od 0,25%, a obim rada izražen u tonskim kilometrima po stopi od 1,0%. Zapravo se izražava neravnomernost u količini prevezenog tereta po pojedinih periodima. U periodu 1991-1994. godine, tj. u periodu sankcija međunarodne zajednice, količina prevezena robe opada po prosečnoj godišnjoj stopi od 11,5%. U periodu 1994-1998. godine

zapravo se rast po prosečnoj godišnjoj stopi od 12,7%. U 1999. godini, dolazi do agresije NATO saveza na Republiku Srbiju, što se odrazilo na pad obima prevoza robe u odnosu na prethodnu godinu od 32,3%. U periodu 2000-2002. godine količina prevezena robe raste po prosečnoj godišnjoj stopi od 5,2%, tako da se skoro približava količini robe prevezena drumskim saobraćajem u 1991. godini (Tab. 2).

Period 2004-2008. godine karakterističan je relativno stabilan period razvoja drumskog saobraćaja bez većih kolebanja po pojedinih godinama u celom ukupnom posmatranom periodu.

Od 2007. godine prevoz robe za i iz Republike Crne Gore vodi se kao prevoz u međunarodnom saobraćaju, što se odrazilo na značajniji rast obima prevoza u izvozu i uvozu u Republiku Srbiju, uz istovremeno usporevno obima prevoza u unutrašnjem saobraćaju.

Izvoz robe drumskim teretnim prevoznim sredstvima sa regionom Republike Srbije u periodu 1991-2008. godine, uz određena kolebanja u periodu sankcija i NATO bombardovanja, iskazuje konstantan rast u celom ukupnom posmatranom periodu.

Uvoz robe, iskazan u količini prevezena robe koji su ostvarili domaći prevoznici u periodu od 1991. do 2008. godine, veći je za preko pet puta. Kod uvoza robe destinacije prevoza nisu tako značajno promene kao kod izvoza, na što ukazuju relativno i zjednačene stope rasta obima rada i količina prevezena robe.

3. REZULTATI PROBNOG ISTRA@IVAWA O PREVOZU TERETA U DRUMSKOM SAOBRA}AJU, U 2008. GODINI


3.1. Ukupan prevoz robe

U 2008. godini na teritoriji Republike Srbije registrovano je 41691 teretno vozilo koja su imala korisnu nosivost jednaku ili ve}u od 3,5 tona, a koja po konstrukciji karoserije vozila i nameni vozila slu`e za prevoz tereta (Graf.3).

Najvi}e teretnih vozila registrovano je u delatnosti trgovine, a zatim u delatnosti industrije i saobra}aja.

Po intervalima nosivosti, registrovano je 28747 vozila sa nosivo}u u intervalu između 3,5 i 10 tona, a 9297 teretnih vozila imalo je nosivost ve}u od 10 tona. U istoj godini registrovano je 3647 tegca-a.


Graf 3. Registrovana teretna prevozna sredstva, Republika Srbija, 2008.



Tokom 2008. godine sa 41691 teretnim vozilom prevezeno 108436 hiq. tona tereta, odnosno 2601 tona tereta po jednom vozilu. U istom periodu registrovano 9515 mil. tonskih

kilometara, odnosno 228226 *tkm* po jednom teretnom vozilu. Prose-an put jedne tone robe iznosi 87,7 *km* (Graf. 4).


Graf 4. Obim rada u drumskom teretnom saobra}aju, Republika Srbija, 2008.



Najve}a koli-ina robe prevezena je u delatnosti trgovine i ugostiteljstva, a najmanje u delatnosti ri barstva, finansijskog posredovanja, komunalnim delatnostima, itd,

odnosno ostalim delatnostima. U delatnosti saobra}aja ostvaren je najve}i, a u delatnosti poqopri vrede i {umarstva najmanji obim rada, iskazan u tonskim kilometrima (Graf. 5).



Najveći prosečan put jedne tone robe od 214,8 kilometra ostavaren je u delatnosti saobraćaja. Teretna vozila registrovana u delatnosti trgovine i ugostiteljstva realizovala su prosečan put jedne tone robe od 122,2 kilometara, poćopri vreda i ribarstva od 87,6 kilometara. U delatnosti industrije i rudarstva realizovan je četiri puta manji prosečan put prevoza jedne tone robe nego u delatnosti saobraćaja. Najmanji prosečan put jedne tone robe realizovala su teretna vozila u delatnosti građevinarstva od 30,7 km i ostalih delatnosti od 27,7 kilometara.

Manje od jedne trećine, od ukupne količine robe prevezla su teretna vozila koja su registrovana za javni drumski saobraćaj. Kako ovaj vid usluge u drumskom saobraćaju znatno organizovaniji je nastupa na tržištu saobraćajnih usluga, većinom u ostvarenim tonskim kilometrima u odnosu na drumski saobraćaj za sopstvene potrebe znatno je veći i iznosi 63,1% u odnosu na ukupno ostvarene tonske kilometre (Graf. 6).

Teretna vozila u drumskom saobraćaju ostvarila su 1537 miliona kilometara, odnosno 36866 km po jednom teretnom vozilu. Isti broj vozila, odnosno 41691 teretno vozilo ostvarilo je 747 miliona kilometara u vozilu bez tereta, odnosno 17935 kilometara po jednom teretnom vozilu. Procenat iskorišćenosti kapaciteta ukupnog voznog parka iznosi 49,2%, a procenat kretanja vozila sa robom je 57,47% na nivou Republike Srbije. Zapaženo je da su najniži koeficijenti kretanja sa robom i malim teretnim vozilima sa registrovanom Beogradu.

3.2. PREVOZ ROBE U JAVNOM DRUMSKOM SAOBRAĆAJU

Tokom 2008. godine, sa 18861 teretnim vozilom registrovanim za javni drumski saobraćaj, prevezeno je 33357 tona tereta i ostvaren obim rada od 6007 miliona tkm. Sa jednim teretnim vozilom, u ovom vidu organizovano drumskog saobraćaja, prevezeno je prosečno 1768 tona tereta i realizovano 318 hiljada tonskih kilometara. U istom periodu ostvaren je prosečan prevezeni put od 180 km, što je za preko dva puta više od ostvarenog prosečnog puta koji je realizovao ukupan vozni park u Republici Srbiji.


Graf 7. Obim rada u javnom drumskom teretnom saobraćaju, Republika Srbija, 2008.

Sa 18861 teretnim vozilom, u ovom vidu usluge u drumskom teretnom saobraćaju, realizovano je 460 hiljada vozni h kilometara sa teretom, odnosno 24388 kilometara po jednom teretnom vozilu (Graf 7).

Prej eni kilometri vozila sa teretom u javnom drumskom saobraćaju, s obzirom na boqu organizaciju ove vrste drumskog saobraćaja,

u-estvuju sa 58,2% u odnosu na ukupan broj prej eni h kilometara realizovani h u svim oblicima organizacije drumskog saobraćaja. Kao i kod drugih parametrima zapa`a se zna-ajno ve}e u-e{ }e vozila javnog saobraćaja registrovani h u Centralnoj Srbiji .

3.3. PREVOZ ROBE U DRUMSKOM TERETNOM SAOBRAĆAJU ZA SOPSTVENE POTREBE

Tokom 2008. godine u drumskom saobraćaju za sopstvene potrebe, sa 22830 teretnih vozila, prevezeno je 75079 hi q. tona tereta i ostvaren obim rada od 3507 mil. *tkm*. Sa jednim teretnim vozilom, u ovom vidu drumskog prevoza tereta, ostvareno je 3287 tona tereta i realizovano 154 hi q. tonskih kilometara.

U istom periodu ostvaren je prose-an prej eni put od 46,7 *km*, { to je skoro ~etiri puta mawe nego u javnom drumskom saobraćaju. Najve}i prose-an put jedne tone robe u saobraćaju za sopstvene potrebe od 73,8 *km* realizovala su drumska prevozna sredstva u Centralnoj Srbiji . Sa 22830 teretnih vozila, u ovom vidu organizacije, prevoza tereta, realizovala su 330 hi q. vozni h kilometara sa teretom, odnosno 14452 *km* po jednom teretnom vozilu (Graf . 8).

Prej eni kilometri vozila sa teretom u javnom drumskom saobraćaju, s obzirom na boqu organizaciju ove vrste drumskog saobraćaja, u-estvuju sa 58,2% u odnosu na ukupan broj prej eni h kilometara realizovani h u svim oblicima organizacije drumskog saobraćaja. Kao i kod drugih parametrima, zapa`a se zna-ajno ve}e u-e{ }e vozila javnog saobraćaja registrovani h u Centralnoj Srbiji .

U-e{ }e ukupne koli -i ne prevezene robe u saobraćaju za sopstvene potrebe, u odnosu na ukupan prevoz robe realizovan sa svim oblicima udr`ivawa, iznosi 69,2%. Jasno je, ve} na prvi pogl ed, da ovaj oblik organizovawa drumskog saobraćaja preveze znatno ve}e koli -i ne tereta.


Graf 8. Obim rada drumskom teretnom saobraćaju za sopstvene potrebe , Republika Srbija, 2008.

Kako je najviše zastupčen u delatnosti građevinarstva i trgovine, to se s obzirom na organizaciju prevoza u tim delatnostima, koja je orijentisana na kraće relacije sa većim

brojem obrta, ostvaruje najveći obim rada iskazan u tonskim kilometrima u odnosu na koloninu tereta koji preveze.

ZAKLJUČAK

Drumski saobraćaj, sa učestvoem od 81,4% u kolonini prevezenog tereta i 58,5% u ostvarenim tonskim kilometrima, ima dominantni udeo u prevozu tereta u Republici Srbiji. To je posebno izraženo u unutrašnjem prevozu tereta, gde drumski teretni vozila, pored direktnog prevoza od korisnika do korisnika, učestvuju i u početno-završnim operacijama pri realizaciji prevoza tereta koji se obavi drugim granama saobraćaja. Javnim drumskim saobraćajem preveze se više od dva puta više tereta nego u

drumskom saobraćaju za sopstvene potrebe. Kako je ovaj vid drumskog teretnog saobraćaja bolje organizovan na tržištu saobraćajnih usluga, to je obim rada, iskazan u tonskim kilometrima u javnom drumskom saobraćaju, veći za 1,7 puta od onog koji realizuju teretni vozila u drumskom saobraćaju za sopstvene potrebe. Dobijeni rezultati, koji su testirani u probnom istraživanju, daju dobru osnovu da se od 2011. godine realizuje redovno istraživanje o drumskom saobraćaju u skladu sa evropskom Regulativom 1172/98.

UVODNE NAPOMENE:

Respektujući interes naših korisnika, i daqe }emo objaviti tekst o bazi vremenskih serija u RZS i njihov spisak iz prethodnih brojeva TRENDOVA (od marta 2004. do juna 2009.) sa metodolozkim izmenama koje su u me|uvremenu nastupile (izmene u nazivu, ili uvo|ewe nove serije).

Nove serije, dodate u teku}oj godini, su oznaene tako }to su }ifre takvih serija podvucene. Ova oznaka se uobi}ajeno ponavqa u dva uzastopna broja TRENDOVA.

U odnosu na prvi broj, u spisku serija je svaki put a`urirana informacija o ukupnom broju serija po pojedinih aktivnostima i du`inama serija u vremenu.

U ovom broju TRENDOVA (septembar 2009. godine) dodate su tri serije iz oblasti Raspodel e (realna prose-na zarada - ukupno, realna prose-na zarada u pri vredi - ukupno i realna prose-na zarada u vanpri vredi - ukupno).

Du`ini z godina, u dr`avnoj statistici (SFR Jugoslavi je, SR Jugoslavi je, Srbije i Crne Gore, i sada Republi ke Srbije) postojala je i odr`aval a se baza vremenskih serija nastala iz podataka zvani }ne statistike i preuzeti h podataka drugi h dr`avni h institucija.

Sve serije u bazi vremenskih serija, su serije ekonomskih pokazateqa. Promene u metodol ogijama pojedini h oblasti pri mewene su prera-unavawem postoje}ih vremenskih ta-aka u seriji prema novim pravil ima, ili skra}i vawem serija, ili na neki drugi na-in. U svakom slu-aju, uvek se nastojalo da se o-uva skup pokazateqa uporedi vi h u vremenu.

Od januara 2004. godine, postoji baza vremenskih serija za Republiku Srbiju (koja je metodol o}ki i sadr` ajno nastavak prethodnih).

INTRODUCTORY NOTES:

Respecting interest of our readers, the following text and the list of series from the data base of Statistical Office of the Republic of Serbia is being repeated from the previous issues of this publication (March 2004 to June 2009). Some methodological changes have been made in the meantime (names of some series have been changed or some new ones have been added).

New series are marked by underlining the code of each one in the list added in current year. This assignment is usually repeated in two successive issues of TRENDS.

Information concerning the series' length and the total number of series for the specific group of economic activities are always accurate.

*In this issue of TRENDS (September 2009), a new series has been included, referring **Distribution sector**. Those are: **real average wage - total, real average wage in economic activities - total and real average wage in non-economic activities - total**.*

During certain number of years, time series data base was established and maintained by state statistics (of SFR Yugoslavia, SR Yugoslavia, Serbia and Montenegro, and now by statistic of Republic of Serbia). The base was obtained from data collected by official statistics and data provided by other public institutions.

*All the established series are the **economic** ones. Any methodological change that appeared was applied by either recalculating previous data according to new rules or by cutting the series, or in some other, appropriate way. In any case, there was always the intention to maintain the data comparability in time.*

Since January 2004, the time series data base for Republic of Serbia has been established, being the continuation of the previous bases from methodological and contents point of view.

Istovremeno su se stekli uslovi za jednu krucijalnu izmenu u metodologiji evaluacije vremenskih serija. Serije odgovarajućih oblasti prikazuju se prema Klasifikaciji delatnosti (KD) koja se primenjuje od januara 2001. godine, a u znatnoj meri se razlikuje od Jedinstvene klasifikacije delatnosti (JKD) koja je bila u primeni više od 20 godina. Deo podataka po KD, statistika prikupljena od januara 2004, dok su podaci za prethodne mesece dobijeni kompilacijom starih podataka iz JKD u KD.

U TRENDOVI MA, se daje kompletan sadržaj baze vremenskih serija (TRENDAGREGAT i TRENDINDEKS), to jest spisak svih serija koje se prate, od kojih je samo određen broj prezentovan u publikaciji. Serije su prikazane po grupama prema oblasti ekonomske aktivnosti kojim pripadaju.

Sve serije su podeljene fizički i funkcionalno u dve paralelne baze: TRENDAGREGAT - TAGR baza vremenskih serija apsolutnih vrednosti pratećih pojava, i TRENDINDEKS - TIND - baza vremenskih serija koje se prate i iskazano u baznim ili lančanim indeksima.

Serije statistike industrije, koje se odnose na proizvodnju i zalihu, i serije statistike cena su samo indeksne.

*At the same time, the crucial change in methodology of time series evaluating could be applied as the new circumstances in statistics were appeared. Time series data (for appropriate sectors) are presented in terms of **Classification of Activities (CA)**, which has been applied since January 2001. There are quite differences between **CA** and **Uniform Classification of Activities (UCA)**, which had been in use for over twenty years. Statistics has been collecting data by CA methodology for some of the sectors since January 2004, while data for previous months have been obtained by compiling data collected by UCA methodology.*

In TRENDS publication the full content of time series data bases (TRENDAGGREGATE and TRENDINDEX) is listed, but only the part of them is chosen to be presented in the publication. The way of grouping series is due to the sector of economic activity they belong to.

All the series provided by statistics are divided into two parallel data bases:

TRENDAGGREGATE - TAGR time series data base covering data in terms of absolute values, and

TRENDINDEX - TIND - time series data base covering data in terms of base or chain indices.

The six digit code is added to each of the series. The last, the sixth digit defines the type of series data:

**0* - for index data, and*

**1* - for absolute values data.*

The series of industry statistics, referring to production and stocks, as well as the series of prices do not have aggregates.

AKTI VNOSTI

Ukupna industrijska proizvodnja je mawa za 11,3%, 13,3% i 14,8% u junu, julu i avgustu ove, u odnosu na proseku proizvodnju 2008. godine, respektivno. Mesečne stope rasta za jun, jul i avgust ove godine iznose 8,7%, -2,3% i -1,7%. Posmatrano u odnosu na jun, jul i avgust prethodne godine, ukupna industrijska proizvodnja ove godine raste, odnosno pada po stopama od 13,2%, 15,5% i 10%, respektivno. Za prvih osam meseci 2009. godine, proizvodnja je mawa za 16,2% u odnosu na isti period prethodne godine, a za 17,4% mawa u odnosu na prosek 2008. godine.

Posmatrano po ekonomskoj nameni, u odnosu na prosek 2008. godine, u junu, julu i avgustu ostvarene su stope u: proizvodnji energije -7,9%, -3,6% i -3,3%; proizvodnji intermedijarnih proizvoda, osim energije -21,6%, -23,4% i -17,3%; proizvodnji kapitalnih proizvoda -6,9%, -18,5% i -35,7%; proizvodnji trajnih proizvoda za { i roku potro{wu -38,5%, -20,8% i -17,4% i proizvodnji netrajnih proizvoda za { i roku potro{wu -2,6%, -10% i -17,4%. Godišnje stope za jun, jul i avgust iznose u proizvodnji: energije 6,5%, -0,2% i 5%; intermedijarnih proizvoda, osim energije -29,9%, -30,8% i -18%; kapitalnih proizvoda -19,2%, -27,2% i -34%; trajnih proizvoda za { i roku potro{wu -37,9%, -20,4% i -20,8% i netrajnih proizvoda za { i roku potro{wu -6,3%, -8,7% i -7,7%.

Gradivna aktivnost, merena u odnosu na radu na gradilištima preduzeća, u drugom kvartalu 2009. bila je mawa za 19,8% od proseka 2008. godine a za 23,4% od drugog kvartala prethodne godine. U prvom polugodju 2009. gradivna aktivnost je mawa za 25,2% nego u prvom polugodju 2008. i mawa za 21% od proseka 2008. godine.

Obim ukupne saobraćajne aktivnosti u drugom kvartalu 2009. bio je mawi za 14% od proseka 2008. odnosno mawi za 16,5% od ukupno ostvarenih saobraćajnih usluga u drugom kvartalu prethodne godine. U prvom polugodju 2009. ukupna saobraćajna aktivnost je mawa za 20% nego u prvom polugodju 2008. i mawa za 21% od proseka 2008. godine. U prvoj polovini ove godine, u ukupnoj saobraćajnoj aktivnosti domaći putnici (79,6%) u odnosu na teretni (33,6%) saobraćaj.

Turistička aktivnost, merena ukupnim brojem noćewa turista, u junu, julu i avgustu beleži mesečne stope rasta od -6,8%, 8,4% i 8,8%. Godišnje stope ukupnih noćewa za jun, jul i avgust iznose -2%, 9,5% i -3,9%. U odnosu na prosek 2008. godine, ukupna noćewa rastu u junu za 11,4%, julu za 35,5% i avgustu za 29,3%. Za prvih osam meseci 2009. za 3,1% je mawe noćewa u odnosu na isti period prošle godine, a više za 2% od proseka 2008. godine. U istom periodu, broj noćewa domaćih turista smanjen za 0,3% dok su noćewa stranih turista povećana za 11,2%, u odnosu na prvih osam meseci 2008. godine.

ACTIVITIES

Total industrial production decreased by 11.3% in June, by 13.3% in July and by 14.8% in August, with respect to the average production in 2008, respectively. Monthly change rates in June, July and August amounted to 8.7%, -2.3% and -1.7%, respectively. Comparing to June, July and August last year, total industrial production has been changing by -13.2%, -15.5% and -10%, respectively. In the first eight months in 2009, industrial production decreased by 16.2% with respect to the same period last year, and decreased by 17.4% with respect to the average in 2008.


Observed by economic use, with respect to the average in 2008, the realized rates in June, July and August were: in production of energy -7.9%, -3.6% and -3.3%; in intermediary production, except energy -21.6%, -23.4% and -17.3%; in production of capital goods -6.9%, -18.5% and -35.7%; in production of durable products for consumption -38.5%, -20.8% and -17.4%; of non-durable products for consumption -2.6%, -10% and -17.4%. Yearly rates in June, July and August amounted to 6.5%, -0.2% and 5% in production of energy; -29.9%, -30.8% and -18% in intermediary production, except energy; -19.2%, -27.2% and -34% in production of capital goods; -37.9%, -20.4% and -20.8% in production of durable products for consumption, and -6.3%, -8.7% and -7.7% of non-durable products for consumption.

The volume of construction activity, expressed by hours of work on construction sites in enterprises, in the second quarter of 2009, was 19.8% below the average in 2008, and 23.4% below the value attained in the second quarter of the previous year. In the first six months in 2009, the construction activity decreased by 25.2% with the respect to same period of the previous year, and it decreased by 21% with respect to the average in 2008.

The volume of transport activities in the second quarter of 2009 was 14% below the average in 2008. In the second quarter of 2009, this activity decreased by 16.5% in comparison with the second quarter of the previous year. In the first six months in 2009, the transport activities decreased by 20% with the respect to same period of the previous year, and it decreased by 21% with respect to the average in 2008. In total transport activity, the passengers' transport is dominant (79.6%) compared to freights' transport (33.6%) in the first six months in 2009.

Monthly rates in tourist activity, measured by total number of tourist nights, amounted -6.8% in June, 8.4% in July and 8.8% in August. Annual rates in June, July and August were -2%, 9.5% and -3.9%, respectively. With respect to the average in 2008, there were increases recorded: 11.4% in June, 35.5% in July and 29.3% in August. In the first eight months in 2009, tourist activity was 3.1% below the level realized in the same period last year, while it was 2% above the average in 2008. In the observed period, the number of domestic tourist nights increased by 0.3%, while the number of foreign tourist nights decreased by 11.2%, compared to the first eight months in 2008.


01000 Industrijska proizvodnja - ukupno

FINAL DEMAND

Ukupne zalihe industrijskih proizvoda u junu, julu i avgustu opadaju po mese-nim stopama od 2,5%, 2,8% i od 5,1%. U odnosu na iste mesece prethodne godine, godi { we stope pokazuju, tako|e pad: 3,7% za jun, 4% za jul i 6% za avgust. Ukupne zalihe, u prvih osam meseci 2009. mawe su za 3% u odnosu na isti peri od 2008, dok su od proseka 2008. godine mawe za 3,6%.

U periodu januar-avgust 2009, u odnosu na isti peri od 2008. gosine, pove}ane su zalihe energije za 2,9%, dok su smawene: zalihe intermedijarnih proizvoda, osim energije za 3,5%, zalihe kapitalnih proizvoda za 18,8%, trajnih i zalihe netrajnih proizvoda za { i roku potro{ wu za 2%, odnosno za 2,1%.

Promet u trgovini na malo u preduze}ima, u teku}im cenama u junu ove godine je mawi za 0,2% a u stalnim cenama za 0,7 %, u odnosu na promet ostvaren u maju. U julu je, u odnosu na jun, u teku}im cenama ve}i za 3,5% a u stalnim za 4,3%, dok u avgustu bele` i pad od 2,5% nominalno i realno za 2,4%. U periodu januar-avgust 2009. godine teku}i promet u trgovini na malo mawi je 3,3%, a u stalnim cenama za 9,5% u odnosu na isti peri od 2008. godine.

Ukupna naplata javnih prihoda za finansirawe javne potro{ we u prvih osam meseci 2009. nominalno je ve}a za 12,5% (realno za 3,4%) u odnosu na isti peri od 2008. godine. U istom periodu (januar-avgust 2009) prihodi i primawa buxeta i drugih korisnika nominalno su ve}i za 14,9% (realno za 5,6%) i prihodi organizacija socijalnog osigurawa su nominalno pove}ani za 5,8%, a realno smaweni za 2,6%, u odnosu na isti peri od prethodne godine.

Kvartalno posmatrano, mawe dinamisan rast u drugom kvartalu imali su prihodi fondova socijalnog osigurawa (nominalno za 5,4%, realno smaweni za 2,5%) u odnosu na ukupno napl}ene prihode (nominalno za 11%, realno za 2,6%) i prihodi i primawa buxeta (nominalno za 12,9%, realno za 4,2%).

Budu}i da je rast tro{ kova ` i vota u Srbiji u kumulativnom periodu (od 8,5%) i drugom kvartalu (od 7,7%) bio ve}i od realnog rasta javnih prihoda (3,4%, 2,6%), prihoda buxeta (5,6%, 4,2%) i prihoda organizacija socijalnog osigurawa (-2,6%, -2,5%) wi hova realna vrednost ni je je ostala o-uvana.

Total stocks of manufactured industrial products decreased in June by 2.5%, in July by 2.8% and in August by 5.1%. With respect to the same months last year, these rates amounted decrease of 3.7% in June, of 4% in July and of 6% in August. In the first eight months in 2009 the total stocks of manufactured industrial products, decreased by 3%, comparing to the same period 2008, and with respect to the average 2008, they decreased by 3.6%.

*In the period January-August 2009, compared to the same period 2008, **stocks of energy** recorded 2.9% increase, the decreases were recorded with: **stocks of intermediary goods, except energy** by 3.5%, **stocks of capital goods** by 18.8%, **stocks of durable goods** by 2%, and **stocks of non-durable consumer goods** by 2.1%.*


Turnover of goods in retail trade in enterprises in June nominally decreased by 0.2% (current prices), and by 0.7% (constant prices), according to turnover of goods in May. In July, with the respect to June, it increased by 3.5% in current prices, while in constant prices it increased by 4.3%. In August it decreased by 2.5% nominally and by 2.4% in real terms. In the period January-August 2009, turnover of goods in retail trade in enterprises decreased by 3.3% (current prices), and by 9.5% (constant prices), comparing to the same period last year.

Collection of gross public revenues for financing public consumption increased nominally by 12.5% (in real terms by 3.4%) in the first eight months in 2009, comparing to the first eight months in 2008. In the same period (January-August 2009), **budget and other users' revenues increased nominally by 14.9%, (in real terms by 5.6%), and **social security organizations revenues** recorded 5.8% nominal increase, and decreased by 2.6% in real terms, with respect to the same period last year.**


*Quarterly observed, less dynamical growth was recorded in **collection of gross public revenues** (nominally 5.4%, in real terms -2.5% decrease) then it was recorded in **social security organizations** (nominally 11%, in real terms 2.6%) and in **budget incomes and revenues** (nominally 12.9%, in real terms 4.2%).*

*Bearing in mind that the increase of consumer prices in Serbia in these periods (**January-August indices** 8.5%) and **second quarter** (by 7.7%) was above the real increase of public revenues (3.4%, 2.6%), **budget and other users' revenues** (5,6%, 4,2%) and **social security organizations revenues** (-2,6%, -2,5%), their real value was not maintained.*

Stocks of manufactured goods in industrial production - energy



Revenues and receipts of budget - total



Ukupan i zvoz roba u prvih osam meseci 2009. godine dostigao je 4,6 milijardi USD i bio je mawi za 31,4% u odnosu na isti period prethodne godine, a za 28,1% mawi od prose-nog i zvoza 2008. godine. U istom periodu, realizovan je ukupan uvoz u iznosu od 19,3 milijardi USD, { to je za 39,2% mawe nego u istom periodu prethodne godine i za 36,5% mawe od prose-nog uvoza 2008. godine.

Ukupan spocnotrgovinski deficit roba u prvih osam meseci 2009. godine iznosio je 5 milijardi USD i mawi je za 45% od deficita u prvih osam meseci prethodne godine. Deficit spocne trgovine u periodu januar-avgust 2009. godine ve}i je za 8,1% od ukupnog i zvoza u prvih osam meseci prethodne godine, ili za 376 miliona USD.

U junu i zvoz raste u odnosu na maj za 9,1%, u jul u mese-no opada za 3,5%. I zvozna akti vnost je u avgustu mawa za 11,1% u odnosu na jul. U odnosu na 2008. godinu, godi { we stope pada i zvoza za jun, jul i avgust iznose 23%, 32,9% i 30,5%, respekti vno. Mese-ne stope rasta uvoza za jun, jul i avgust iznose 13,6%, 2,9% i -11,4%, respekti vno, a godi { we (u odnosu na iste mesece 2008. godine) -38,4%, -43,1% i -35,4%, respekti vno.

U periodu januar-avgust, tako je domi ni ra uvoz proi zvoda za reprodukciju (5,590 milijardi USD), proi zvoda za { i roku potro{ wu (2,595 milijarde USD) i sredstava rada (1,472 milijardi USD). Godi { we, kumul ati vne stope rasta i zvoza (po datom redosledu) iznose: -39,1%, -11,7% i -21,4%, a uvoza: -42,3%, -25,6% i -45,5%, respekti vno.

EXTERNAL TRADE

Total exports of goods in the first eight months in 2009 amounted to 4.6% billion USD what represents 31.4% decrease comparing to the same period last year, and 28.1% decrease with respect to the average exports in 2008. In the same period, the total imports attained the value of 19.3 billion USD, what is 39.2% decrease, comparing to the same period last year, and 36.5% decrease with respect to the average imports in 2008.

Total external trade deficit of goods in the first eight months in 2009 amounted to 5 billion USD, what represents 45% decrease in comparison with the deficit recorded in the same period previous year. The external trade deficit in the period January-August 2009 exceeds the total exports in the same period of the previous year by 8.1% or by 376 million USD.

In June, exports increased by 9.1% with respect to May, and decreased in July by 3.5%, monthly rate. In August, a decrease of 11.1% in exports activity was recorded, with respect to July. With respect to the same months in 2008, annual rates in June, July and August amounted -33.4%, -35.1% and -30%, respectively. In June, July and August imports recorded monthly rates: 13.5%, 2.9% and -11.4%, respectively, and yearly rates (compared to the same months of the previous year) were: -38.4%, -43.1% and -35.4%, respectively.




In the first six months in 2009, the exports decreased by 31.2%, and the imports decreased by 39.2% with respect to the first six month in 2008, too.

According to the economic use of products, in the first eight months 2009, the dominant products in the structure of exports were intermediate goods (2.838 billion USD), consumer goods (1.354 billion USD) and capital goods (448 million USD). In period January-August the dominant products in the structure of imports were also intermediate goods (5.590 billion USD), consumer goods (2.595 billion USD) and capital goods (1.472 billion USD). Cumulatively, for these goods, yearly rates were for exports -39.1%, -11.7% and -21.4%, and for imports -42.3%, -25.6% and -45.5%, respectively.

ZAPOSLENOST

Za prvih osam meseci 2009. godine ukupna zaposlenost je za 5,9% manja od proseka iz 2008. godine, i za 5,8% manja od ukupne zaposlenosti za osam meseci prethodne godine. Zaposlenost u preduzećima, ustanovama i organizacijama u drugom kvartalu 2009. je za 0,6% ispod proseka zaposlenosti u 2008. godini i manja je za 0,7% u poređenju sa istim periodom prethodne godine. Za prvih osam meseci 2009. godine zaposlenost privatnih preduzetnika i zaposlenih kod njih je za 18,5% manja od proseka iz 2008. godine, a za 18,9% od njihove zaposlenosti za osam meseci prethodne godine.

U drugom kvartalu 2009. zaposlenost u privrednim delatnostima (preduzećima, ustanovama i organizacijama) opada po stopi od 1,9% u odnosu na prosek 2008. i opada za 1,8% u odnosu na isti period prethodne godine. U prvih osam meseci ove godine, privredna zaposlenost je za 2,1% ispod proseka privredne zaposlenosti 2008. a za 1,7% manja od istog perioda prethodne godine.

U drugom kvartalu 2009. godine zaposlenost u vanprivrednim delatnostima (preduzećima, ustanovama i organizacijama) raste po stopi od 2,3% u odnosu na prosek 2008. a za 2,2% u odnosu na isti period prethodne godine. U prvih osam meseci ove godine, vanprivredna zaposlenost je za 2% veća od proseka 2008. odnosno za 2,2% od istog perioda prethodne godine.

Broj registrovanih lica koja traže zaposlenost, ili ukupna nezaposlenost, u drugom kvartalu 2009. veća je za 2,3% od proseka nezaposlenosti u 2008. godini i za 0,3% od nezaposlenosti u drugom kvartalu 2008. godine. U prvih osam meseci ove, u odnosu na isti period prethodne godine, broj nezaposlenih lica (stvarna nezaposlenost) manji je za 0,1%, dok je od proseka iz 2008. godine manji za 2,2%.

Veliki raskorak između visoke tražnje za radom, izražene brojem nezaposlenih lica, i niske ponude rada, izražene preko broja slobodnih radnih mesta, izražen je i dalje. Broj registrovanih slobodnih radnih mesta u junu 2009. iznosi 59,7 hiljada i manji je za svega 0,6% od broja slobodnih radnih mesta u maju ove godine. U julu se taj broj smanjio za 0,8% u odnosu na prethodni mesec. Ponuda rada u avgustu (43,3 hiljade) 17,3 puta je manja od broja nezaposlenih lica, ili, ponuda rada u avgustu činila je tek 5,8% stvarne tražnje za radom. Pod pretpostavkom usklađene kvalifikacione strukture ponude rada i stvarne tražnje za radom, 94,2% ponude rada ostalo bi nepokriveno.

EMPLOYMENT

In the first eight months in 2009, the total employment decreased by 5.9%, comparing to the average in 2008, and decreased by 5.8% comparing to the same period previous year. Employment in enterprises, institutions and organizations in the second quarter in 2009 was 0.6% below the average in 2008, and 0.7% below the level attained in the same period previous year. In the first eight months in 2009, the private entrepreneurs, persons performing activities independently and their employees decreased by 18.5%, comparing to the average in 2008, and by 18.9% comparing to the same period previous year.


In the second quarter of 2009, the employment in economics (enterprises, institutions and organizations) decreased by 1.9% comparing to the average in 2008, and decreased by 1.8% with respect to the same period previous year. In the first eight months of this year, employment in economics decreased by 2.1%, comparing to the average in 2008, and decreased by 1.7% comparing to the same period previous year.

In the second quarter of 2009, the employment in non-economics (enterprises, institutions and organizations) increased by 2.3% comparing to the average in 2008, and by 2.2% with respect to the same period previous year. In the first eight months of the current year, employment in non-economics increased by 2% comparing to the average in 2008, and increased by 2.2% comparing to the same period previous year.


The number of the registered unemployed seeking work in the second quarter of 2009, increased by 2.3% in comparison with the average unemployed in 2008, and by 0.3% comparing to the same period previous year. The number of unemployed (real unemployed) decreased by 0.1% in the first eight months this year, comparing to same period in 2008, and compared to the average of 2008, the decrease was 2.2%.

A considerable discrepancy between the high labor demand, expressed in the number of the unemployed persons seeking work, and the low labor supply, expressed in the number of job vacancies, was still pronounced. The number of registered vacancies in June 2009 was 59.7 thousand, and decreased just by 0.6% with the respect to May this year. In July, this number represented 0.8% decrease with respect to the previous month. The labor supply in August (43.3 thousand) was 17.3 times lesser than to the real number of persons seeking work, representing just 5.8% of total labor demand. This means that 94.2% of labor supply wouldn't be covered; assuming that qualification structure of the labor supply matches the qualification structure of labor demand.

Prose-no i spl a}ena neto zarada bez poreza i dopronosa u junu je iznosila 31768 dinara (u pri vredi 29310 dinara, u vanpri vredi 37000 dinara), { to je nominalno vi { e za 2,2% (u pri vredi za 2,3%, u vanpri vredi za 1,6%), a real no za 2,2% (u pri vredi za 2,2% i vanpri vredi mawe za 2,4%) u odnosu na prethodni mesec. U ul u je prose-no i spl a}ena neto zarada (32553 dinara, u pri vredi 30333 dinara, u vanpri vredi 28915 dinara) pove}ana u odnosu na jun, za 2,5% (u pri vredi 3,5% i vanpri vredi za 0,8%) u nominal nom i nosu, dok je real no pove}ana za od 3,4% (u pri vredi 4,4%, u vanpri vredi 1,7%). U avgustu je prose-no i spl a}ena neto zarada 31338 dinara (u pri vredi 30333 dinara, u vanpri vredi 37284 dinara) mawa od zarade u jul u, za 3,7% (u pri vredi za 4,7% i vanpri vredi za 1,8%), dok real no smawewe i znosi 3,6% (u pri vredi za 4,6%, u vanpri vredi za 1,7%).

DISTRIBUTION

Average net wages (salaries), without taxes and contributions, disbursed in June amounted to 31768 Dinars (in economy 29310 Dinars, in non-economic activities 37000 Dinars), what represents the nominal increase of 2.2% (in economy by 2.3%, in non-economic activities by 1.6%) and the real increase of 2.2% (in economy by 2.2%, in non-economic activities decreased by -2.4%), compared to the previous month. In July, comparing to June, average net wage (salary), without taxes and contributions, disbursed (32553 Dinars), in economy 30333 Dinars, in non-economic activities 28916 Dinars) increased by 2.5% (by 3.5% in economy, in non-economic activities by 0.8%) nominally, but in real terms the increase was 3.4% (4.4% in economy, 1.7% in non-economic activities). In August, comparing to July, average net wage (salary), without taxes and contributions, disbursed is 31338 Dinars (in economy, 30333 Dinars, in non-economic activities 37284 Dinars) and it decreased by 3.7% (by 4.7% in economy, by 1.8% in non-economic activities), but in real terms there was decrease of 3.6% (by 4.6% in economy, by 1.7% in non-economic activities).

According to statistical data, the increasing trend of average net wages turns down in May, as it happens every year. Last and this year a trend continued, when it was interrupted in March and May and in this year in August, also.

Annual growth rates of net wages in June, July and August amounted, nominally, to 9.3%, 10.7% and 6.4%, while they were 1.4%, 2.4% and 1.4%, in real terms.

From the beginning of the year until the end of August, the average net wages increased nominally by 7.3% (by 9% in economy, by 2.1% in non-economic activities) comparing to the average in 2008, and by 10.6% (by 12.1% in economy, by 6.2% in non-economic activities) comparing to the same period previous year.


In period January-August 2009, comparing to 2008, the budget revenues distributed to republic budgets recorded an increase of 22.2% nominally (12.4% the real value) and grew slower than the increase of budget revenues distributed to communes and towns, which that decreased by 11.3% nominally, and 18.2% the real value, in this period.

Annual growth rates of budget revenues distributed to republic budgets in June, July and August amounted, nominally, to 19.5%, 35.8% and 85.4%, while they were 8.9%, 25.7% and 71.8%, in real terms.

Annual growth rates of budget revenues distributed to communes and towns in June, July and August amounted, nominally, to -13.7%, -1.1%, -11.8%, while they were -19.9%, -8.4%, -18.2%, in real terms.


07040 Real ne prose-ne neto zarade bez poreza i dopri nosa - ukupno

Real average net wages without taxes and contributions - economic activities





Real average net wages without taxes and contributions - non-economic activities





CENE

Cene proizvođa-a industrijskih proizvoda bel`e mese-ni rast za jun i avgust od 2,1% i 1,1%, a pad u jul u od 0,3%. Posmatrano po nameni EU, u avgustu su najviše porasle cena proizvođa-a energije za 3,9% i cene proizvođa-a intermedijarnih proizvoda za 0,3%. Pale su, na mese-nom nivou cene proizvođa-a trajnih proizvoda za { i roku potro{wu (za 0,2%), zati m cene proizvođa-a kapitalnih proizvoda (za 0,5%) i cene proizvođa-a netrajnih proizvoda za { i roku potro{wu porasle za 0,2%.

Od po-etka godine do avgusta, po sektori ma industrije, u odnosu na decembar 2009. cene proizvođa-a u proseku su ve}e u sektoru va|ewa rude i kamena za 29,2%, zati m u sektoru prera|iva-ke industrije za 5,1%, a cene proizvodwe el ektri -ne energije, gasa i vode za 1,1%. U avgustu, u odnosu na decembar 2009. najviše su porasle cene proizvođa-a energije za 13,6% i cene proizvođa-a kapitalnih proizvoda za 9,2%. Tako je, porasle su i cene trajnih i netrajnih proizvoda za { i roku potro{wu (za 4,6%, odnosno za 3,6%) kao i cene intermedijarnih proizvoda (za 1,3%).

Cene na malo su u junu porasle za 0,4%, pri -emu su od roba pale cene poqopri vrednih proizvoda (za 6,4%) i cene sve`ih prehrambenih proizvoda (za 0,7%), dok su najviše porasle cene industrijski prehrambenih proizvoda (za 1,3%). Mese-na inflacija u jul u bel`i pad od 0,2%, a u avgustu rast od 0,1%. U jul u su zabel`ena pojedini wewa, sl i -na junski m (poqopri vredni proizvodi za 17,5% i sve`i prehrambeni proizvodi za 3,6%) dok su najviše poskupeli industrijski prehrambeni proizvodi (0,4%). U rastu cena na malo u avgustu (od 0,1%) predwa-e cene poqopri vrednih proizvoda (od 2,5%) i cene usluga (0,4%), dok su cene roba ostale na nivou iz jul a. U rastu cena na malo u septembru (od 0,3%) predwa-e poqopri vredni proizvodi koji su poskupeli za 0,7% i cene usluga koje su poskupele za 0,6%, dok su industrijski prehrambeni proizvodi i prehrambeni proizvodi ukupno su pojedini li za 0,4%, odnosno za 0,3%.

Tro{ kovi `i vota u junu rastu za 0,1%, u jul u i avgustu padaju za 0,9%, odnosno za 0,1%, dok u septembru bele`e rast od 0,2%. U junu su najviše pove}ani izdaci za saobra}ajna sredstva i usluge (1,8%), dok su smaweni tro{ kovi za ishranu (0,9%). PRICES


Producers' prices of manufactured goods increased in June and August by 2.1%, by 1.1%. In July they recorded a decrease of 0.3%. Observed by use (EU-classification), the biggest growth recorded in August was with prices of energy by 3.9% and prices of intermediary products which increased by 0.3%. The decrease recorded in August was with the prices of durable products for consumption (by 0.2%), the prices of capital goods (by 0.5%) and the prices of non-durable products for consumption (by 0.2%).

From the beginning of the year until August, observed by industrial sectors, producers' prices were greater in average than prices in December 2009. in sectors: mining and quarrying by 29.2%, than manufacturing by 5.1% and prices of electricity, gas and water supply by 1.1%. In August, with respect to December last year, the greatest increase was recorded in producers' prices of energy (13.6%) and prices of capital products (9.2%). The increase was recorded with prices of durable products (4.6%), prices of non durable products (3.6%) and prices of intermediary products (1.3%).


The retail prices increased in June by 0.4%. The decrease was recorded with the prices of agricultural products (6.4%) and fresh agricultural food products (0.7%), while the biggest growth was with the prices of industrial non food products (1.3%). Retail prices decreased in July by 0.2, and in August they increased by 0.1%. In July, as well as in June, the retail prices recorded decrease (prices of agricultural food products by 17.5% and fresh agricultural food products by 3.6%) while the biggest growth was with the prices of industrial food products (by 0.4%). In growth of the retail prices in August (0.1%) with respect to July, precede the prices of agricultural products (2,5%), and prices of services (0.4%) while prices of goods maintained the same level as it was in July. In the growth of the retail prices in September (0.3%), prices of industrial agricultural products increased by 0.7% and prices of services by 0.6%, while the prices of industrial food products and total food products decreased by 0.4% and 0.3%, respectively.

Consumer prices in June increased by 0.1%. Monthly growth rates of consumer prices in July and August recorded decrease of 0.9% and of 0.1%, respectively, but in September they increased by 0.2%. In June, the biggest growth of expenditure was for traffic facilities of 1.8%, while expenditure for food decreased by 0.9%. In July, the biggest decrease was for food (3%) and the biggest growth was for shoes and clothes (1.3%). In August, the total index (0.1%) was influenced by expenditure increase for services (by 0.6%), for food (1%), shoes and clothes (0.1%) and for goods (0.2%). In September, the biggest growth was for accommodation (0.6%) and services (0.5%). From the beginning of the year until the end of September, consumer prices increased by 6%.

- energy*



MONETARNI SEKTOR

U junu, 2009. godine, novčana masa M1 je mesečno nominalno porasla za 0,8%, u julu za 1,1% i u avgustu za 2,9%. Realno raste u junu za 0,3%, julu za 1,3%, odnosno u avgustu za 2,8%. Za prvih osam meseci 2009. godine, novčana masa je mava za 2,7% u odnosu na isti period prethodne godine, takođe za 2,7%, u odnosu na prosek 2008. godine.

Učestvo gotovog novca u optičaju u novčanoj masi u junu 2009. godine iznosi 66,5%, dok u julu i u avgustu učestvo iznosi 62,7%, odnosno 59,2%. Stava gotovog novca u optičaju (58,4 milijardi dinara) u junu je nominalno mava za 2,8% od stava u maju, a realno za 3,2%. U julu je gotov novac u optičaju nominalno veći za 5,4% a realno za 5,5%, u odnosu na prethodni mesec. U avgustu je masa gotovog novca (54,5 milijardi dinara) nominalno mava za 4%, a realno mava za 4,1% od mase gotovog novca iz jula.

U isto vreme, depozitni novac u junu, julu i u avgustu beleži nominalne mesečne stope: od 3%, -1,3% i 7,1%, respektivno i realne stope od 2,5%, -1,1% i 7%, respektivno.

U junu i julu je došlo do nominalnog povećanja novčane mase M2 za 1,4% (realno za 1%), odnosno za 1,9% (realno za 2%), takođe je i u avgustu zabeleženo nominalno povećanje za 2,6% (realno za 2,5%),

Novčana masa M3 je u junu, julu i u avgustu za 1,8%, 0,4%, odnosno za 1,4% nominalno veća u odnosu na prethodni mesec ove godine (realno za 1,4%, 0,5% i za 1,4%).

Kamatne stope pravnih lica na depozite na tekućim i giro računima, kao i na oročene depozite do jednog meseca, na mesečnom nivou, u nominalnom iznosu date su u tabelama na sledećoj strani. Nominalne i realne vrednosti kamatnih stopa su prikazane na grafikoni ma.

Realne kamatne stope pravnih lica na depozite na tekućim i giro računima negativne su u svim mesecima 2006-2009, osim u julu, septembru i oktobru 2006, zatim u novembru i decembru 2008. godine, takođe u junu, julu i septembru 2009. godine.

Realne vrednosti kamatnih stopa pravnih lica na oročene depozite do jednog meseca, variraju u celom periodu, a najviše u periodu januar-avgusta 2009. godine (-1,9% do 2,2%).

MONETARY SECTOR

In June the money supply M1 increased nominally by 0.8%, in July by 1.1%, and in August it increased by 2.9% (in real terms 0.3%, 1.3% and 2.8%), with the respect to previous month. In the first eight months in 2009, money supply decreased by 2.7% with respect to the same period last year, and by 2.7% with respect to the average in 2008, too.

The share of cash in circulation in June 2009 amounted to 66.5%, and in July and August it amounted to 62.7% and 59.2%. In June, cash in circulation (58.4 billion Dinars) decreased by 2.8%, nominally, and by 3.2% in real terms, compared to May. In July, cash in circulation increased nominally by 5.4%, (in real terms 5.5%), with respect to June. In August, cash in circulation (54.5 billion Dinars) recorded 4% nominal decrease, and 4.1% decrease in real terms, comparing to July.

At the same time, in June and August, deposit money nominally increased by 3% and by 7.1%, but in July decreased by 1.3%. Monthly rates, in real terms, were: 2.5%, -1.1% and 7%, respectively.

In June and July, the money supply M2 increased nominally by 1.4% (by 1% in real terms) and nominally by 1.9% (by 2% in real terms). In August, it increased nominally by 2% (by 2.6% in real terms), too.


The money supply M3 in Jun, July and August increased nominally by 1.8%, 0.4% and 1.4%, (in real terms by 1.3%, 0.5% and 1.4%), with respect to previous month, respectively.

Interest rates of legal entities for deposits on current and giro accounts and on time deposits up to one month (on monthly level, in nominal terms) are presented in the tables on the next page. Real and nominal values of these interest rates are presented on graphs.


Real interest rates of legal entities for deposits on current and giro accounts follow the trend being negative during the whole period 2006-2009, except in July, September and October 2006, than in November and December 2008 and in June, July and August 2009.

Real values of interest rates of legal entities for time deposits up to one month vary during the whole presented period, but the largest variations were in period January-May 2009 (-1.9% to 2.1%).

Cash in circulation











METODOLOŠKA OBJAŠNENJA

Publikacija TRENDOVI ima za cilj da nosi ocenu ekonomske politike zemlje pruži ažurnu informaciju o tekućim kretanjima u privredi, kao i o njihovim dugoročnim ili cikličkim ponašanjima. Zato je na grafikonima prikazana i trend-ciklus komponenta, zajedno sa originalnim mesečnim podacima, dok su u tabelama dati samo originalni podaci - bazni ili lančani indeksi za tekuću i dve prethodne godine.

Baza indeksnih podataka koji se prezentuju godišnje se ažurira preračunavanjem indeksa tekuće godine u odnosu na prethodnu godinu kao baznu (=100).

Za svaku prezentovanu oblast ekonomske aktivnosti daje se i tekstualna analiza kretanja pronađenih pojava za period obratun datom broju publikacije.

Početkom prvog broja ove publikacije (mart 2004), serije iz (odgovarajućih) oblasti se prikazuju prema Klasiifikaciji delatnosti (KD) koja se primenjuje od januara 2001. godine, a znatno se razlikuje od Jedinstvene klasiifikacije delatnosti (JKD) koja je bila u primeni više od 20 godina. Deo podataka po KD statistički prikupljen od januara 2004, dok se podaci za prethodne mesece dobijaju kompilacijom starih podataka iz JKD u KD.

TRENDOVI, kao i baza podataka izavih, zasnovani su na podacima Republičkog zavoda za statistiku Srbije i Narodne banke Srbije, a od januara 2003. i na podacima Ministarstva finansija i ekonomije - Uprava za javna plaćanja, Centrala, Beograd. Od januara 2003. poslovne ZOP-a, o bruto naplati i raspodeli javnih prihoda, preuzele su Nacionalna fondacija i Ministarstvo finansija - Uprava za trezor - Centrala Beograd, potrebni podaci su raspoloživi. Podatke o novčanim tokovima prikupljaju poslovne banke i prošlejuh Narodnoj banci Srbije.

Posebno napomenu da od drugog kvartala 1999. godine serije ne sadrže podatke za Kosovo i Metohiju.

METHODOLOGICAL EXPLANATIONS

The ultimate aim of the TRENDS publication is to provide accurate information on current economic trends to the economic policy makers, as well as information on their long-term and/or cyclical behavior. For this reason, the graphs present both, the original monthly data and the trend-cycle components, while the tables present only original data - base or chain indices for the current and two previous years.

Database of index data, which are presented in the publication, is being made accurate by recalculating indices according to the preceding year as the referent year (=100).

For each sector of economic activities covered by the publication, there is a regular short analysis of current economic trends in the observed period.

Starting March 2004, when the first issue of this publication was announced, data series (for appropriate sectors) are presented in terms of Classification of Activities (CA), which has been applying since January 2001. There is quite a difference between CA and Uniform Classification of Activities (UCA), which was in use for over twenty years. Statistics has been collecting data by CA methodology for some of the sectors since January 2004, while data for previous months are obtained by compiling data collected by UCA methodology.

TRENDS, as well as data base beyond, use data collected by Statistical Office of the Republic of Serbia, by National Savings Bank and, since January 2003, by Ministry of Finances and Economy - Directorate for public payments in Belgrade (Also, since January 2003, tasks of Clearing and Payment Service concerning data collection for gross revenues and distribution of public revenues, have been taken over by National Savings Bank and Ministry of Finances - Treasury Administration, Belgrade and these requisite data are available. The data on monetary flows have been collected by commercial banks and passed to National Bank of Serbia).

Specially remarked is the fact that starting the second quarter 1999, all the series do not include data for Kosovo and Metohia.

Baza podataka

U Republičkom zavodu za statistiku sve serije u statistici su organizovane u bazu podataka (sačinjavaju dve analogne logičke celine TRENDAGREGAT i TRENDINDEKS). Baza sadrži preko 600 serija.

U publikaciji: "Uputstvo za korišćenje baze indeksa Ekonomski trend - EKT serija indeksa o privrednim kretanjima" (MM br. 384, SZS, 1999), objašnjena je procedura kojom se može pristupiti bazama podataka. Slična procedura biće primenjena i na instalaciji Republičkog zavoda za statistiku i opisanu adekvatnoj, analognoj publikaciji.

Na sledećem načinu biće kompilirane metodološke publikacije u kojima je opisan koncept i izgradnja vremenskih serija: "Interni metodološki baze podataka - Serije agregata i indeksa o privrednim kretanjima - Ekotrend" (RD, god-VII, br. 7, SZS, 1993) i "Baza indeksa Ekonomski trend - EKT - Priprema i ažuriranje serija indeksa o privrednim kretanjima za SR Jugoslaviju" (MSRD br. 36, SZS, 1997).

Ostale metodološke napomene

Trend - ciklus komponenta je računata metodom *X11*, kompjuterskim paketom *X11-ARIMA*, koji je razvila kanadska statistika.

Trends for economic indicators cover the following areas:

- (1) *Activities,*
- (2) *Final demand,*
- (3) *External trade,*
- (4) *Employment,*
- (5) *Distribution,*
- (6) *Prices,*
- (7) *Monetary sector.*

Data bases

There is time series data base available in Statistical Office of Republic of Serbia. The base consists of two analogue logical parts: TRENDAGREGATE and TRENDINDEX. There are over 600 time series in the base.

The publication titled "Instructions for Use of Index Data Base Economic Trend - EKT Indices Series on Economic Trends" (MM, No. 384, FSO, 1999), edited by FSO of Yugoslavia, describes the procedure which enables access to the bases. The similar procedure is going to be applied in the Republic Statistic, and is going to be described in the adequate publication

Another two methodological publications that explain the plan for building time series data bases are also going to be compiled: "Internal Methodology of Data Base - Series of Aggregates and Indices on Economic Trends - Ekotrend", (RD, Year - VII, No. 7, FSO, 1993) and "Economic Trend Database - EKT-Creation and Updating of Index Series on Economic Trends for FR Yugoslavia" (MSRD, No. 36, FSO, 1997).

Other methodological remarks

The trend - cycle component is calculated by X11 method, by means of the X11-ARIMA program package, developed by Statistics of Canada.

Serijski indeksi industrijske proizvodnje (ukupno i po sektorima), kao i odgovarajuće serijske zaliha gotovih proizvoda u industrijskoj proizvodnji, izvedene su iz podataka o fizičkom obimu proizvodnje prema statističkoj metodologiji ponderisane i agregirane podataka iz ove oblasti.

Radnici na gradilištima obuhvaćaju stvarno odrađene radne angažovane na gradilištima u redovnom radnom vremenu, kao i u prekovremeni sati, za sve radnike u preduzećima iz oblasti građevinarstva, kao i u jedinicama koje obavljaju građevinsku delatnost a nalaze se u sastavu građevinskih preduzeća.

Prosečna neto zarada zaposlenih, bez poreza i doprinosa, prema metodologiji Republičkog zavoda za statistiku, izražena u prosečnoj bruto zaradi umanjenoj za poreze i doprinose. Bruto zaradu zaposlenih iznose zarade koje su zaposleni ostvarili za obavljeni rad i vreme provedeno na radu, uvećana zarada, naknada zarade i druga primanja.

Podaci o primanjima i izdavanjima stanovništva se ne evaluiraju, te se odgovarajuće serijske zalihe završavaju sa decembrom 2002. godine.

U skladu sa Zakonom o izmenama i dopunama Zakona o radnim odnosima ("Službeni glasnik RS" br. 28/2001), od 1.6.2001. godine zarade zaposlenih prate se po bruto obračunu.

Nominalni monetarni agregat - novčana masa M1, iskazana je kao mesečna stanka definisana kao zbir gotovog novca u optekaju i depozitnog novca.

Depozitni novac obuhvata sredstva na računima i drugim računima vlasnika novčanih sredstava, kao i novčana sredstva na računima lokalne samouprave sa plaćanjima bez ograničenja.

Index series of industrial production (total and by sectors), as well as analogous index series of stocks of manufactured goods in industrial production, are obtained from data on volume of the production by means of statistical methodology for evaluation of totals from weighted data.

Hours of work performed at construction sites include working hours of workers engaged at construction sites during the regular working time and overtime work, for all the workers in enterprises from the field of construction, as well as in the units that perform construction activity and are in composition of non-construction enterprises.

Average net wages (salaries) of the employees', without taxes and contributions (according to the methodology applied by Statistical Office of Serbia) are represented by wages (salaries) - gross, reduced for taxes and contributions. Employees' wages (salaries) - gross consist of: wages realized by employees for work done and time spent at work, higher wages, remunerations and other incomes.

Data on receipts and expenditure of population are not going to be evaluated anymore. Thus, series of these data end by December 2002.

According to the Law on Changes and Amendments to the Labor Relations ("Official Gazette of RS" No. 28/2001.), of 1.6.2001 the salaries of the employees are recorded on the gross calculation basis.

Nominal monetary aggregate - money supply M1 is presented as a monthly balance and it is defined as the sum of cash money in circulation and deposit money.

Deposit money covers resources on giro and current accounts and resources of municipality government with unlimited payments.

Nominalni monetarni agregat - novčana masa M2, iskazana je kao mesečno stave i definisana kao zbir novčane mase M1 i dinarskih depozita (kratkoročnih i dugoročnih).

Nominalni monetarni agregat - novčana masa M3, iskazana je kao mesečno stave i definisana kao zbir novčane mase M2 i deviznih depozita (bez stare devizne štednje).

Kamatne stope su date na mesečnom nivou.

Svi podaci su dati na mesečnom nivou na bazi proseka prethodne godine (=100), uključujući i tokove monetarnih agregata. Izuzetak čine serije o cenama koje su predstavljene i lančanim indeksima (prethodni mesec = 100). Ovo je učinjeno da bi se preglednije pratile mesečne promene cena.

Pre kratke analize svake oblasti ekonomske aktivnosti, dat je spisak prezentovanih serija.

Nominal monetary aggregate – money supply M2 is presented as a monthly balance and it is defined as a sum of money supply M1 and Dinars deposits money (short-term and long-term).

Nominal monetary aggregate – money supply M3 is presented as a monthly balance and it is defined as a sum of money supply M2 and devises deposits money (without old devises savings).

Interest rates are given on monthly level.

All data present monthly series based on the preceding year average (= 100), including the trends of monetary aggregates. The exception are the series on prices represented by base indices as well as by the chain monthly indices (preceding month = 100). This has been done in order to obtain a better insight on monthly changes of prices.

For each economic activity sector, before short analytic comments, there is a list of the presented series.
