

The estimate was made on the basis of the sample. If the estimate of industrial production of small-sized enterprises is included, the industrial production index for November 2010/2009 average, for total industrial production stands at 109,9 and for manufacturing 113,4.

Industrial production in the Republic of Serbia, in November 2010 was by 01% lower compared to November 2009 and was by 10% greater compared to 2009 average. Industrial production for January - November 2010, compared to the same period last year was by 03% greater.

Observed by sectors, November 2010, compared to November 2009, in the mining and quarrying sector increased by 04%, while the production in the manufacturing sector increased by 02%, while the production in the sector for electrisity, gas and water supply saw a 11% fall.
