#### Methodological explanations

Producer's price index for industrial products – total, is a new price index that is calculated pursuant to the methodology harmonized with the EU recommendations and standards.

The index shall be accounted according to the data compiled for producer's price index for industrial products in domestic market and producer's export price index for industrial products.

The index is calculated for the level of the Republic of Serbia.
