Gross domestic product of the Republic of Serbia, 2008–2011

The Statistical Office of the Republic of Serbia publishes the results of annual calculations of Gross domestic product (GDP) and its final use, at current prices, for the period 2008-2011. For calculating GDP and other macroeconomic aggregates, we apply the methodology adjusted to the System of National Accounts 1993 (*SNA93*), the European System of Accounts 1995 (*ESA95*), the internationally recognised standards and recommendations, as well as the Classification of Activities (in compliance with NACE Rev. 2).

According to the calculations by production and expenditure approach, the Gross domestic product of the Republic of Serbia in 2011 amounted to RSD 3 208 620.2 million, at current prices.

Observed by activities, in 2011 the largest share in the creation of GDP had the section of manufacturing -14.0%, the section of real estate activities -10.7%, the section of wholesale and retail trade; repair of motor vehicles and motorcycles -9.2%, and the section of agriculture, forestry and fishing -9.1%.

The use of GDP in 2011 was structured in the way that household final consumption expenditure had the share of 76.0%, government individual consumption expenditure – 12.8%, government collective consumption expenditure – 6.5%, gross fixed capital formation – 18.5%, exports of goods and services – 36.6%, and imports of goods and services – 53.0%.

Starting from 1999 the Statistical Office of the Republic of Serbia has not at disposal and may not provide available certain data relative to AP Kosovo and Metohia and therefore these data are not included in the coverage for the Republic of Serbia (total).
