Gross domestic product of the Republic of Serbia, 2012.

The Statistical Office of the Republic of Serbia publishes the results of annual estimation of Gross domestic product (GDP), by production and expenditure approach, at current and constant prices, for 2012.

Gross domestic product in 2012 amounted to RSD 3 348 689.2 million, at current prices. Compared to the previous year, GDP increased by 4.4% in nominal terms.

Observed by activities, in 2012 the largest share in the creation of GDP had the section of manufacturing - 14.4%, the section of real estate activities - 10.0%, the section of wholesale and retail trade; repair of motor vehicles and motorcycles - 9.5% and the section of agriculture, forestry and fishing - 8.3%. The use of GDP was structured in the way that household final consumption expenditure had the share of 76.0%, government final consumption expenditure - 19.9%, gross fixed capital formation - 21.4%, exports of goods and services - 40.3%, and imports of goods and services - 58.2%.

Compared to the previous year, the real GDP fall equalled 1.5%.

Observed by the main activities, in 2012 the real growth of Gross value added (GVA) was noted as follows: the section of manufacturing - 1.1%, the section of financial and insurance activities - 4.0%, the section of information and communication - 4.8%. The most expressive fall of GVA was recorded for the section of agriculture, forestry and fishing - 17.3% and the section of electricity, gas, steam and air conditioning supply - 7.1%. Regarding the GDP use, real growth was noted for gross fixed capital formation - 14.4%, but household final consumption expenditure expressed a real fall of 1.9%.

Starting from 1999 the Statistical Office of the Republic of Serbia has not at disposal and may not provide available certain data relative to AP Kosovo and Metohia and therefore these data are not included in the coverage for the Republic of Serbia (total).
