## Expenditures for environmental protection in the Republic of Serbia in 2015

Environmental protection expenditures are incurred in order to prevent, reduce and eliminate pollution or any other degradation of the environment due to the process of production or use of goods and services.


In 2015, total expenditures for environmental protection amounted to RSD 34826 million, which is 14.1% higher than in the previous year. Investments amounted to RSD 12292.3 million, which is 22.4% more than last year, while current expenditures were RSD 22533.7 million, which is 10.1% more than last year.

Annual share of investments for environmental protection in the expenditures for environmental protection amounted to 35.3%, while current expenditures had a share of 64.7%.

Out of total investments for environmental protection, investments for Air protection accounted for 64.3%, for Wastewater management 10.5%, for Waste management 13.3%, for protection and remediation of soil, groundwater and surface water 1.8%, for protection against noise and vibration 0.1%, for protection of biodiversity and landscape 0.1% and for Other environmental protection activities 9.8%

Out of total current expenditures for environmental protection, current expenditures for Air protection accounted for 2.7%, for Wastewater management 13.6%, for Waste management 60.7%, for protection and remediation of soil, groundwater and surface water 4.6%, for noise and vibration abatement 0.3%, for protection of biodiversity and landscape 4.4% and for Other environmental protection activities 13.7%

In 2015 the share of environmental protection expenditures in Gross domestic product equalled 0.9%.
