PREFACE

The Statistical Office of the Republic of Serbia publishes in this bulletin data on social protection institutions in the Republic of Serbia for 2015. The data are taken from the Republic Institute for Social Protection and refer to the territory of the Republic of Serbia.

Data on children and youth using the services of social protection institutions are obtained by means of reports of institutions for the accommodation of children deprived of parental care, institutes for children's and youth's up-bringing, as well as by means of reports of institutions for children and youth with developmental disabilities.

Data on social protection of seniors and adults with disabilities, being the beneficiaries of institutions' services, are obtained by means of reports of institutions for the accommodation of seniors and reports of institutions for adults with disabilities.

The bulletin contains also basic methodological notes allowing the users to understand and use the data correctly.

Since 1999, the Statistical Office of the Republic of Serbia has no available data for AP Kosovo and Metohia, therefore they are not included in the data for the Republic of Serbia (total).

Methodological explanations

Data sources

The Statistical Office of the Republic has been taking data on social protection institutions from the Institute of Social Protection since 2010.

The reports of institutions for accommodation of children deprived of parental care, institutions for children's and youth's up-bringing, as well as by means of reports of institutions for children and youth with developmental disabilities are sources of data on children and youth using the services of the aforesaid social protection institutions.

Data on social protection of adults are obtained from the reports of institutions for the accommodation of adults and the seniors and institutions for accommodation of adults with disabilities.

Compared to the previous issues, this bulletin has been modified due to methodology changes.

Institutions for children and youth

Institutions for children and youth provide temporarily or permanently accommodation, food, health protection, upbringing, education and vocational training to children and youth needing this type of protection.

Institutions for the accommodation of children deprived of parental care provide accommodation to children and youth deprived of parental care, whether without both parents, abandoned by parents, of unknown parents or whose parents are prevented from performing parental duties, as well as of children from families with poor social and financial standing. Those institutions provide also upbringing and education to children and youth until conditions are met for their return to their own families, placement in another family or institution, as well as prepare them for independent living.

Institutions for the accommodation of children and youth with developmental disabilities provide temporary or permanent accommodation, care, upbringing and education, as well as training for work under special conditions.

Institutions/institutes for children and youth deal with the reception and temporary accommodation of children affected by educational/developmental neglect in order to return them as soon as possible to their parents or guardians, i.e. competent body – if caught wandering or begging. Besides accommodation, provided are upbringing, education and vocational training.

Institutions for adults

Institutions for adults and the seniors (shelters, retirement and old people homes, gerontology centres, homes for adults with disabilities, homes with intellectual disabilities, homes for mentally ill persons) provide accommodation, food, care and health protection to adults and the seniors who do are deprived of family care, with disabilities and not being in the position to receive adequate care and help in own family.
