PREFACE

The Statistical Office of the Republic of Serbia publishes data on crime statistics of juvenile perpetrators of criminal offences in the Republic of Serbia. The data are collected in regular statistical surveys on minors against whom the procedure on criminal report and preparatory procedure have been terminated (form SK-3), and presented are under the name "Crime reports". The data obtained from the statistical survey on juvenile person against whom the criminal procedure before the jury has been ended by a finally binding court decision (form SK-4) are shown in the section "Charges and convictions".

The presented data refer to statistical survey conducted in 2015. Data on types of criminal offences, decisions by crime report, criminal offences for charged and convicted minors, as well as on type of decision and pronounced criminal sanctions are given as ten-year presentations and cover the period 2006-2015.

This bulletin also contains the basic methodological explanations which are to serve users for better understanding and using of the data. Up to 2003, the bulletins of crime statistics were regularly issued in the Federal Statistical Office.

Starting from 1999 the Statistical Office of the Republic of Serbia has not at disposal and may not provide available certain data relative to AP Kosovo and Metohija and therefore these data are not included in the coverage for the Republic of Serbia (total).

Methodological explanations

Data sources

Data on crime statistics of reported juvenile perpetrators are obtained from the statistical survey conducted via the questionnaire SK-3- "Questionnaire on a minor against whom the proceeding on the grounds of a crime report and preparatory proceeding were terminated".

According to the provided guidelines, monitoring (recording) of the reported minors – perpetrators of criminal offences is performed continuously. Statistical questionnaire SK-3 is completed at the moment of termination of the proceeding in the competent Senior Public Prosecutor's Office.

Data on crime statistics of charged and convicted juveniles in this bulletin are provided on the grounds of the statistical survey conducted in the form SK-4 – "Questionnaire on a minor against whom the criminal proceedings terminated by a finally binding juvenile court decision". This statistical form is completed by all competent higher courts after the judge's – president's agreement that the decision is final, meaning that: the proceeding was suspended, the security measure was pronounced, without imposing sanctions or the sentence was pronounced – educational measure.

In accordance with the Law on juvenile criminal offenders and criminal protection of juveniles (hereinafter referred to as the Law), which has been applied since January 1st 2006, the criminal proceeding against juveniles is initiated in all cases only on the request of public prosecutor for juveniles, who is obliged to participate until the end of the proceeding. Public prosecutor submits request for initiating preparatory proceeding. First – instance proceeding is carried out by judge for juveniles and juvenile panel of a higher court. The panel comprises a juvenile judge and two lay judges. Juvenile judge is the president of the panel.

Data for 2015 have been provided from the regular statistical survey on crime statistics.

Coverage

The statistical surveys on minor perpetrators of criminal offences cover minor perpetrators of criminal offences – persons who at the moment of criminal offence committal were 14 and not yet 18 years old, and against whom criminal proceedings on the grounds of a crime report have not been initiated or against whom preparatory proceedings are suspended or the criminal proceedings terminated by a finally binding court decision.

Data in this publication refer to juvenile reported persons against whom the criminal proceedings on the grounds of a crime report or preparatory proceedings terminated, and the mentioned data are shown by year of birth, sex, previous convictions, family situation and type of decision of the public prosecutors' office.

Regarding the charged minors – perpetrators of criminal offences against whom the proceeding ended by a finally binding court decision, presented are the data on criminal offences, types of decisions, crime report submitters and way of submitting the report, including year of criminal offence committal, duration of detention, duration of proceeding and previous conviction. Personal characteristics of minor perpetrator involve data on sex and age.

For convicted minors – perpetrators of criminal offences, exposed are the data on pronounced sentence – measure: juvenile prison, warning and directing measures (disciplinary measures), intensified supervision measures and institutional measures, as well as data on security measures, previous conviction. Moreover, given are the data on age and sex, educational attainment, national affiliation, co-perpetrator, number of persons involved in committing the criminal offence, occasion and family situation.

Explanations of particular terms and features

"A **criminal offence** is an offence set forth by the Law as criminal offence, which is unlawful and committed with guilty mind/*mens rea*. There is no criminal offence without an unlawful act or culpability, notwithstanding the existence of all essential elements of a criminal offence stipulated by Law". (Article 14 of the Criminal Code)

Subject of the survey and observation unit is the juvenile perpetrator of criminal offence (minor).

Juvenile perpetrators of criminal offences are the persons who, at the moment of criminal offence committal, were 14 and not yet 18 years old, and who committed the criminal offence as: perpetrator, coperpetrator, agitator or assistant.

Junior minor is the person who at the moment of criminal offence committal was 14 and not yet 16 years old. Only educational measures can be passed to a junior minor.

Senior minor is the person who at the moment of criminal offence committal was 16 and not yet 18 years old. Against senior minor, apart from educational measures, in particular cases, measure of juvenile imprisonment can be pronounced.

A person who at the moment of criminal offence committal was not yet 14 years old cannot be criminally responsible person, i.e. no criminal sanctions can be pronounced nor other measures applied against such persons. These persons are not covered by the surveys.

If a single person committed several concurrent criminal offences, the most serious one is monitored, while other offences are presented cumulatively and are not related to the perpetrator. **The most serious criminal offence** is meant to be the offence for which the most serious sentence is proposed. In case the same type and degree of sentence is proposed for two or more concurrent criminal offences, **the most serious offence** is taken to be the one for which more serious sentence is pronounced — measure, i.e. the act which public prosecutor / deputy of public prosecutor / judge — juvenile court considers as the most serious act.

When several persons participated in a single offence committal, each participant is taken to be the observation unit, meaning that the same offence is recorded as the feature of every participant and particular question determines whether the offence was done as complicity.

A **reported juvenile person** is taken to be a juvenile against whom criminal proceedings on the grounds of a crime report have not been initiated (crime report rejected), against whom preparatory proceedings are suspended or the charge motion has been submitted to a juvenile court for pronouncing sentence or measure.

An **accused juvenile person** is considered to be a juvenile against whom a charge motion has been submitted to a juvenile court for pronouncing sentence, i.e. educational measure, so the proceedings were terminated by a finally binding judgment by which: proceeding was suspended, security measures without imposing criminal law sanctions were pronounced or juvenile imprisonment or educational measure were pronounced.

A **convicted juvenile person** is a juvenile perpetrator of criminal offence against whom a criminal law sanction – juvenile imprisonment or educational measure has been passed.

The following **criminal sanctions** can be pronounced to minor perpetrators of criminal offences: educational measures and juvenile prison.

Educational measures are:

- Warning and directing measures (before adopting the Law, these were disciplinary measures): court admonition and alternative sanctioning;
- 2. **Intensified supervision measures:** intensified supervision by parents, adoptive parent or guardian; intensified supervision in another / foster family; intensified supervision by guardianship authority; intensified supervision with daily attendance in relevant rehabilitation and educational institution for juveniles; special obligations to the measure of intensified supervision;
- 3. **Institutional measures:** remand to rehabilitation institution, remand to correctional institution, remand to special institution for treatment and acquiring of social skills.

Sentence of juvenile prison can be pronounced only to an elder juvenile who committed a criminal offence punishable by imprisonment of over five years if due to high degree of guilt, nature and gravity of the offence an educational measure would not be appropriate. Juvenile detention may not last less than six months or more than five years and shall be pronounced in full years and months. Juvenile detention of up to ten years may be pronounced for criminal offences carrying a statutory punishment of twenty - year imprisonment or more severe punishment or in case of joinder of at least two criminal offences punishable by more than ten - year imprisonment.

The term **previous convictions** encompass all previous convictions involving educational measures and juvenile prison.

Parents of a minor relate to parents of a juvenile person born as legitimate or illegitimate, parents who exercise parental rights on the basis of legitimation or adoption, at the time of criminal offence committal. So as to determine social origin of a minor, working status of parents is shown regardless whether parents are alive or not.

The Statistical Office of the Republic of Serbia has issued the **Classification of criminal offences** covering every criminal offence enlisted in the Criminal Code of Serbia. It has been applied in statistical surveys on adult and minor perpetrators of criminal offences since January 1st 2006, after adoption of the Criminal Code of Serbia. Changes in Classification of criminal offences have been caused by the amendments to the Criminal Code.

Statistical publications

Data on crime statistics have been published in the bulletins of the Federal Statistical Office up to 2002.
