Sale and Purchase of Agricultural, Forestry and Fishing Products

- I quarter 2020 -

Total value of sale and purchase of agricultural, forestry and fishing products in the Republic of Serbia in the first quarter 2020, relative to the same period 2019, increased by 12% at current and by 12.7% at constant prices. In the structure of sale and purchase value, in the first quarter 2020, the greatest share was realized in the groups as follows: cereals (27.9%), livestock (23.4%), milk (18.4%) and industrial crops (7.9%).

Methodological explanations

Data are collected by "Monthly report on realized agricultural production of legal entities in agriculture" (PO-TRG- 33) and from "Monthly report on purchase of agricultural products from individual holdings" (TRG-31). Value of delivered products is calculated according to selling producers' prices and value of purchase is computed according to purchasing prices, which organizations pay to individual holdings, for taken products. Value of sale, i.e. purchase does not include the following: VAT, packaging, transportation costs, costs of keeping and storage, discounts, as well as the determined bonuses that producers get for delivered products. Data on livestock, in table 3, refer only to cattle for slaughter. The main aim of the survey is obtaining the data that are used for calculation of producers' price indices of agricultural and fishing products (Statistical release CN 40).

Starting from 1999 the Statistical Office of the Republic of Serbia has not at disposal and may not provide available certain data relative to AP Kosovo and Metohija and therefore these data are not included in the coverage for the Republic of Serbia (total).
