Indices of producer prices of agricultural and fishing products, April 2020

Producer prices of agricultural and fishing products in April 2020, compared to the same month of 2019, were increased by 0.1% average.

Observed by main product groups, compared to the same month of the previous year, the biggest impact on the rise in prices was noted in the groups: Industrial crops (8,1%) и Fruit (48,4%).

Producer prices of agricultural and fishing products in April 2020, compared to March 2020, were decreased by 0.5% average.

Observed by main product groups in April 2020, compared to the previous month, the biggest impact on the fall in prices was noted in groups: Animals (-1.4%) and Cereals (-0.8%).


Producer prices of agricultural and fishing products in period January-April 2020, compared to same period 2019, on average decreased by 0.6%.


Observed by main groups of products, in period January-April 2020 compared to same period 2019, the biggest impact on the fall in prices was noted in the groups: Cereals (-5.6%) and Vegetables (-40.3%).





Methodological explanations

The aim of the survey is the calculation of average prices and indices of producer prices of agricultural and fishing products. Average prices of agricultural and fishing products are calculated based on quantities and values of purchased and sold products, obtained from the Trade Statistics and Agricultural Statistics. Starting from 2013, indices of producer prices of agricultural and fishing products shall be calculated according to the new methodology that is harmonized with the European standards.

The survey covers companies and entrepreneurs which are purchasing products of agriculture and fisheries directly from family holdings in order to sell or process purchased products, as well as legal entities that sell products of agriculture and fisheries from their own production.

Data are published about 12th of each month (the reference period m-2), in the edition Statistical Release, with the mark CN40, and they are also presented on the website of the Statistical Office of the Republic of Serbia (www.stat.gov.rs).
