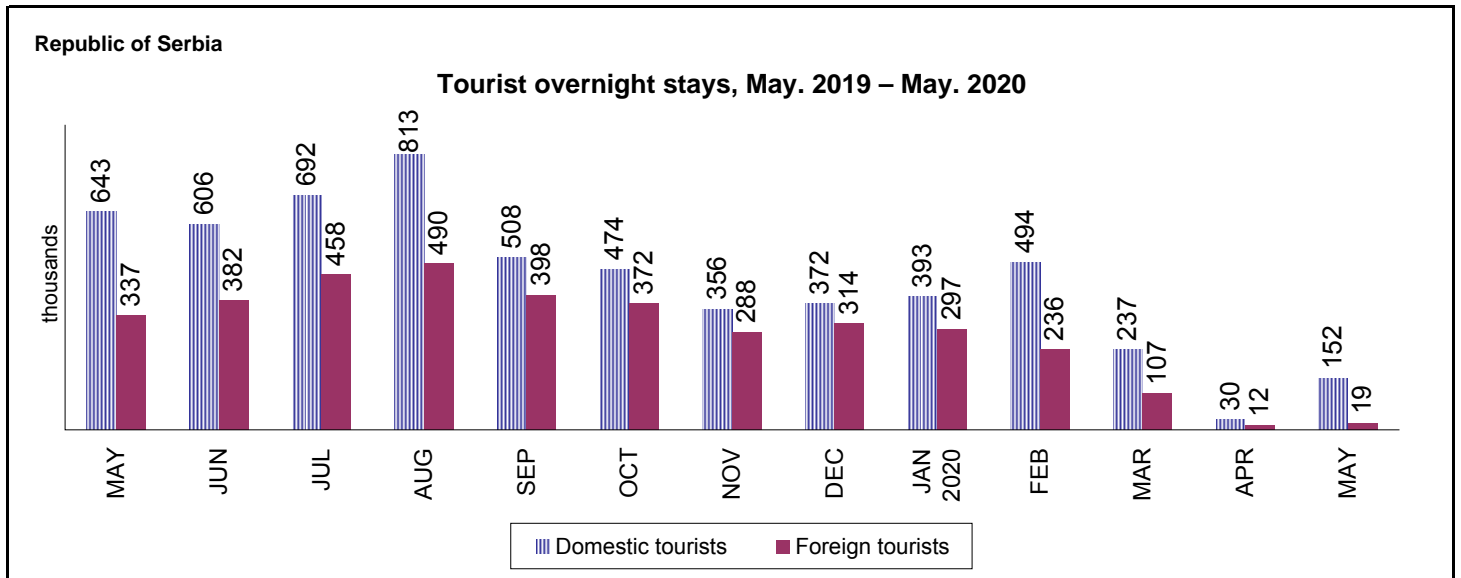

METHODOLOGICAL NOTES

Data on tourist turnover and capacities are collected by regular monthly survey on tourist arrivals and overnight stays in accommodation facilities (form TU-11). Data in this Release represent previous results and may undergo certain modifications.

Monthly report on tourist arrivals and overnight stays in commercial accommodation facilities is submitted by all business entities (companies, institutions, cooperatives, unincorporated enterprises, etc.) that offer the accommodation services.

A tourist is taken to be every person who spends at least one night in an accommodation facility in the place visited.

Domestic tourist is every person whose place of residence is in the Republic of Serbia and who spends at least one night in an accommodation facility in some other place in the Republic of Serbia, outside the place of residence.

Foreign tourist is every person whose place of residence is outside the Republic of Serbia and who temporarily stays in the Republic of Serbia, spending at least one night in an accommodation facility.

Tourist is registered in every facility he/she stays in. Therefore, due to changed place or accommodation facility, tourist is registered once again.

Tourist place relates to organizational and functional unit that has already created tourist offer, natural values, cultural heritage and other monuments important for tourism, with municipal, transport and tourist infrastructure, also including other facilities and contents for tourist accommodation and stay.

Data by statistical territorial units are provided on the basis of Nomenclature of Statistical Territorial Units („Official Gazette of RS“, No. 109/09 and 46/10).
