### Methodological explanation

Indices of producers' prices of industrial products, calculated on the basis of prices collected from domestic producers and realized on domestic market, present the oldest indices of producers' prices and have been used as one of the basic short-term indicators for economic analysis and reviews, for decades ago. The survey is conducted on the representative sample.
