## PREFACE

The first publication issued by the Statistical Office of the Republic of Serbia (SORS) was The Statistical Yearbook (1949). At the beginning of the fifties of the last century, the following publications were issued: Statistical release, Monthly Statistical Review and Bulletin, and all of them are still being published. In the mid-sixties, SORS introduced the new serial publication Working Document, and in the seventies, Municipalities in Serbia. Since 2002, SORS has significantly enriched its publishing activity, by overtaking the model of certain publications issued by the former Federal Statistical Office, such as: Demography statistics, Economic trends and Statistical Calendar.

In 2004, the Office has also started issuing own publications on the website. An advantage of this kind of issuing is free publications' download. Together with the development of information - communication technologies and databases, the users are offered the possibility of overtaking all statistical data directly from the website.

This catalogue presents all publications issued in the period October 2017 – October 2018, including also list of Books of 2011 Census of population, households and dwellings and 2012 Census of Agriculture.

The first number from the edition Bulletin was printed in 1955 and it presents one of the oldest publications of SORS. Bulletins relate to results of a single survey or a single statistical area.

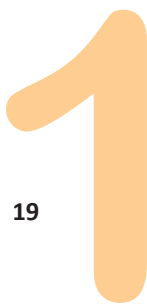

## Forestry in the Republic of Serbia, 2017

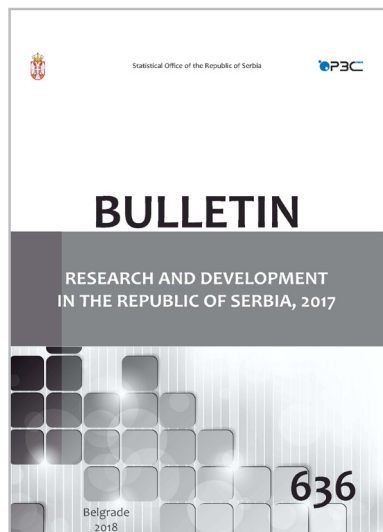

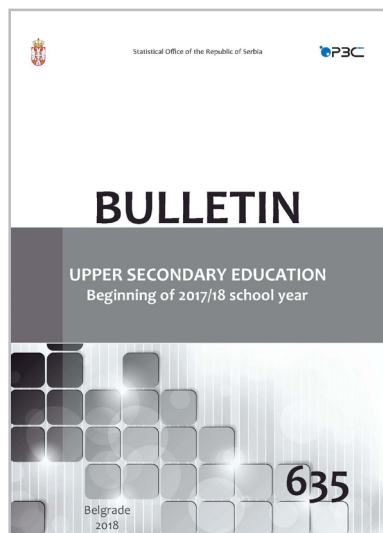

Employees in the R&D activity are shown by occupation, scientific qualifications, type of employment and working hours, as well as by full-time equivalent (FTE). The data on research personnel, by age, have been published annually since 2007. In tables on research projects, finalised and non-finalised works are shown by type, ordering party and scientific field, while published works, inventions and patents are presented by publishing destination, i.e. sale, and by scientific field. The bulletin contains a tabulated presentation of funds for R&D work by origin, costs by source and use, as well as a presentation of investments in the R&D activity. The results refer to 2017, the territory of the Republic of Serbia, Srbija – sever, Srbija – jug and to the regions: Beogradski region, Region Vojvodine, Region Šumadije and Zapadne Srbije, and Region Južne i Istočne Srbije.

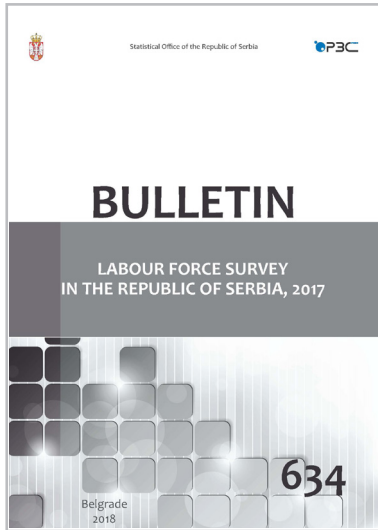

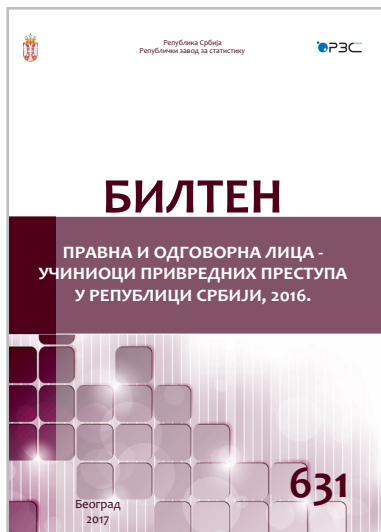

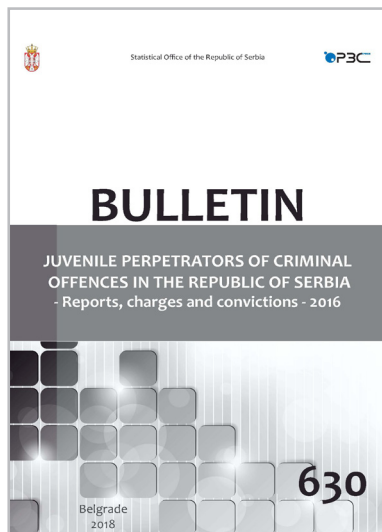

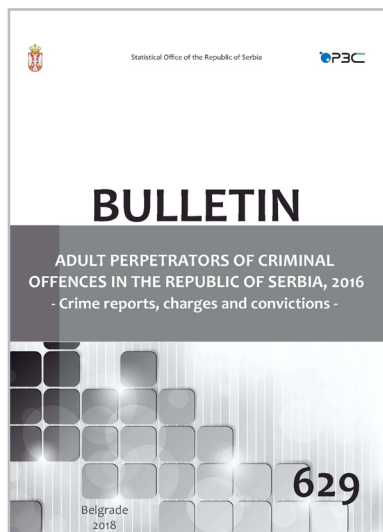

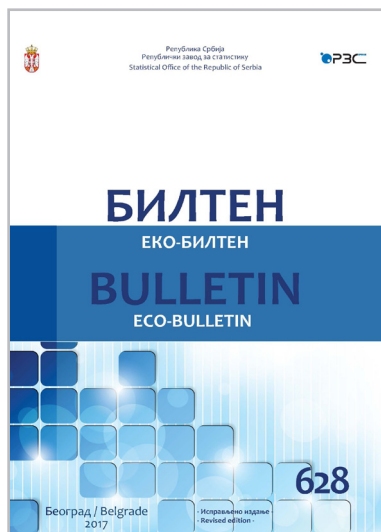

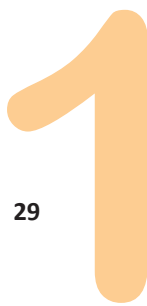

This bulletin introduces new indicators based on data from customs declarations and Statistical Business Register, starting with the data from 2008. The aim of introducing the mentioned indicators is providing wider set of information by comparing economic information on enterprises with the most important external trade indicators, thus enabling detailed and more profound analysis of external trade structure.

The publication contains selected macroeconomic indicators for unincorporated enterprises performing activities in 2017 on the basis of data from Tax Administration and Business Registers Agency.

Presented are the processing results for number of unincorporated enterprises, number of employees, realized turnover and gross value added. The data are, from the territory view, shown on the levels 1 and 2 of the Nomenclature of Statistical Territorial Units (NSTU): Serbia – North and Serbia – South (NSTU-1) and on the level of regions (NSTU-2) - Beogradski region, Region Vojvodine, Region Šumadije i Zapadne Srbije and Region Južne i Istočne Srbije. Regarding the activities performed by unincorporated enterprises, the data are presented on the level of sections and sub-sections of the Classification of Activities.

# Regional gross domestic product Regions and areas of the Republic of Serbia, 2016



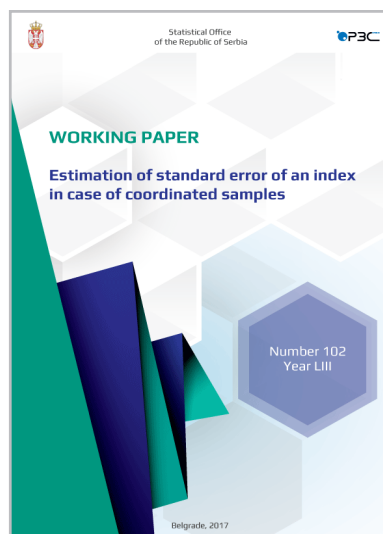

Regional GDP presents regional equivalent of GDP as the most significant macroeconomic aggregate of a national economy and indicator of its productivity and efficiency in production of goods and services necessary for various sorts of consumption.

The calculation of regional GDP is, as a part of the system of national accounts of the Republic of Serbia, based on principles and methodology of European system of national accounts (ESA 2010), and Nomenclature of statistical territorial units of the Republic of Serbia (NSTU), which has been harmonized with the European Nomenclature of territorial units for statistics (NUTS). The main conceptual frame is the Eurostat's manual "Regional Accounts Methods". In accordance with the ESA 2010 and the Eurostat methodology of regional accounts, as a separate statistical territorial unit displayed is "extra regio", i.e. extraterritorial units of the Republic of Serbia. Those are diplomatic and consular missions, embassies of the Republic of Serbia abroad and in other parts of the economic territory of the Republic of Serbia outside its territorial boundaries.



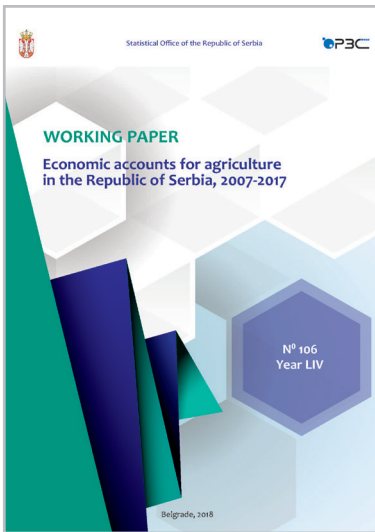

In the working paper “Estimation of standard error of an index in case of coordinated samples” a solution to the problem of precision estimation of an annual index was sought for operating income, turnover and operating expenses that are compiled by the Quarterly Structural Business Survey. In the simulation study, comparisons were made among several estimators for the coefficient of correlation of totals estimated using the common units of the current and the previous year samples coordinated by permanent random numbers. In addition, for the index estimator, an approximate coefficient of variation was estimated as a linear combination of the limits of the interval comprising this coefficient of variation.

Economic accounts for agriculture are created for the purpose of monitoring and evaluating the effects of agricultural policy.

The data are expected to provide a basis for analysing the production processes of the agricultural sector and the primary income generated in agriculture. They also ensure international comparability of the EAA results with the other countries (international comparability), as well as comparisons with the results of other economic activities in the national economy. The presented results of calculations of the economic accounts for agriculture in the Republic of Serbia cover the period from 2007 to 2017 and relate to the elements of production account and factor income in agriculture.

The results are offered at current and constant prices.

Also provided are the methodological principles with a detailed description of calculation methods, data sources and main features.



## Methodologies and standards

Methodologies and standards are the serial publications with detailed explanations of statistical methods, standards, and instructions for survey conducting.

The texts include definitions of population, statistical units and their features, classifications, nomenclatures and other explanations of statistical processes.

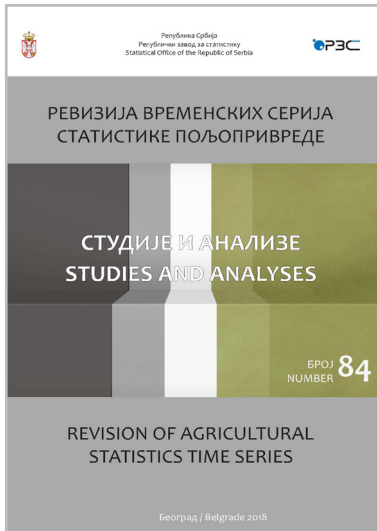

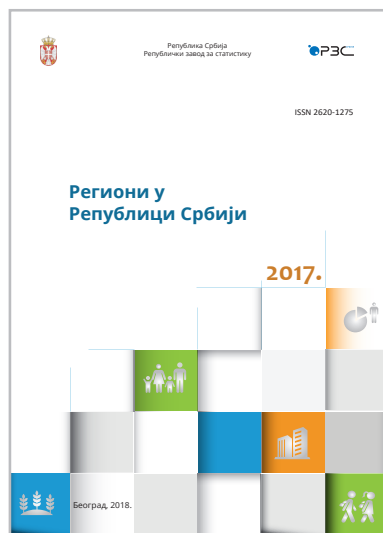

## Regions in the Republic of Serbia, 2017

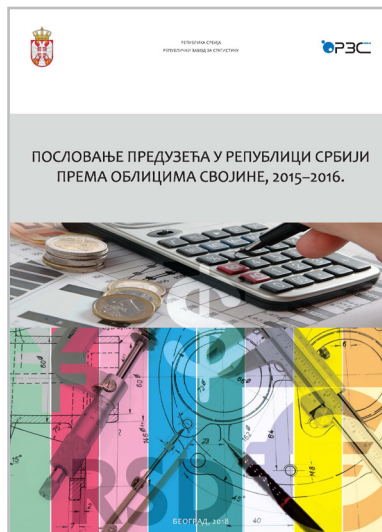

## Business activities of enterprises in the Republic of Serbia, by ownership types, 2015-2016

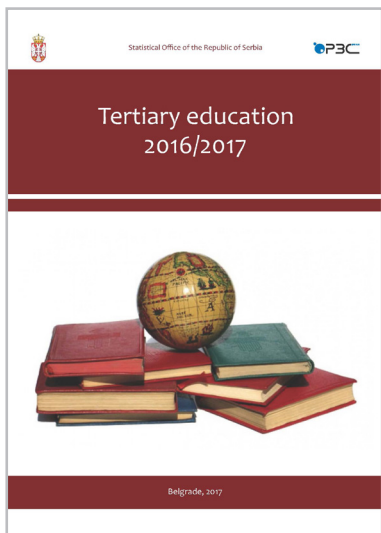

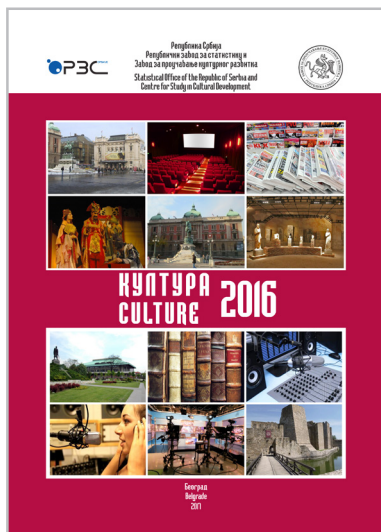

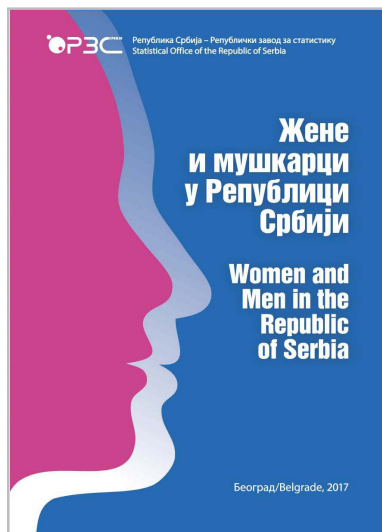
