### Methodological explanation

The aim of conducting this survey is calculating indexindices of import prices and it is also used as a short – term indicator in macroeconomic analysis and reviews. The survey is conducted on the representative sample. Prices are collected in foreign currencies and indices are calculated in dinar value, according to the mean exchange rate of the National Bank of Serbia.
