Sale and Purchase of Agricultural, Forestry and Fishing Products – Il quarter 2025 –

Total value of sale and purchase of agricultural, forestry and fishing products in the Republic of Serbia in Q2 2025, relative to the same period 2024, decreased by 12.5% at current prices.

In the first six months 2025, compared with the same period 2024, the total value of sale and purchase of agricultural, forestry and fishing products in the Republic of Serbia decreased by 10.4% at current prices, and by 14.5% at constant prices.

Methodological explanations

Data are collected by "Monthly report on realized agricultural production of legal entities in agriculture" (PO-TRG-33) and from "Monthly report on purchase of agricultural products from individual holdings" (TRG-31). Value of delivered products is calculated according to selling producers' prices and value of purchase is computed according to purchasing prices, which organizations pay to individual holdings, for taken products. Value of sale, i.e. purchase does not include the following: VAT, packaging, transportation costs, costs of keeping and storage, discounts, as well as the determined bonuses that producers get for delivered products. Data on livestock refer only to cattle for slaughter. The main aim of the survey is obtaining the data that are used for calculation of producers' price indices of agricultural and fishing products (Statistical release CN 40).

Starting from 1999 the Statistical Office of the Republic of Serbia has not at disposal and may not provide available certain data relative to AP Kosovo and Metohija and therefore these data are not included in the coverage for the Republic of Serbia (total).
